005 Chair Strobeck Meeting called to order at 1:07 p.m.

WORK SESSION ON HB 2087 A-ENG.

006 Chair Strobeck Discussed the House and Senate versions of the measure and described the differences. The (-A2) amendment would maintain the \$2 million cap in the Senate version, but with the effect of a \$1 million expenditure limit for the tax credit in the 1999-01 biennium and another \$1 million in the 2001-03 biennium. (Exhibit 1)

- 014 Sen. Wilde "Although I understand you are looking for a compromise, I don't find this to have as significant an impact as I would like."
- 019 Chair Strobeck The Ways and Means Committee does not have this budgeted; \$1 million could be accommodated in the budget this biennium, but the \$2 million in the Senate version could not be funded for the biennium.
- 025 Staff Distributed revenue impact statement for the (-A2) amendment. (Exhibit 2)
- 026 Chair Strobeck MOTION: MOVED (-A2) AMENDMENT TO HB 2087 A-ENG. BE ADOPTED. HEARING NO OBJECTION, THE CHAIR SO ORDERED. (REP. WILLIAMS EXCUSED)
- 032 Chair Strobeck MOTION: MOVED THAT THE HOUSE CONCUR IN THE SENATE AMENDMENTS DATED JUNE 3 AND THAT THE BILL BE FURTHER AMENDED BY THE (-A2) AMENDMENT AND REPASSED.
- 035 VOTE ROLL CALL VOTE: MOTION PASSED 5-1-0
- MEMBERS VOTING AYE: SENATORS BEYER, HARTUNG;  
REPRESENTATIVES KAFOURY, WILLIAMS, CHAIR STROBECK
- MEMBERS VOTING NAY: SENATOR WILDE
- MOTION CARRIED.
- CHAIR STROBECK AND SEN. BEYER WILL CARRY THE BILL IN THEIR RESPECTIVE CHAMBERS.
