		 Suggested recommendations include: Receding from the amendment adding the credit for the stay-at-home parents and move back to the introduced Senate bill. Change the implementation date in the original Senate measure to January 1, 2001 to lessen the revenue impact to the 1999-2001 biennium.
032	Chair Miller	MOTION: MOVED BY CONCEPTUAL AMENDMENT THAT THE EFFECTIVE DATE BE CHANGED FROM JANUARY 1, 2000 TO JANUARY 1, 2001.
039	Sen. Dukes	In support of the suggestion that the stay-at-home credit amendment be deleted. Understands the need to move to 2001. "The House version, with the refundable tax credit, is directed at the people whom most need it. Spoke to the revenue impact of the House version of the measure and how it more closely adheres to the Republicans priority of not incurring holes in future budgets. This is a better direction, but I still prefer the refundable version of the measure."
053	Rep. Rosenbaum	"Concurred with comments made by Sen. Dukes, however I could not support the Senate version of the bill, even with a delayed implementation date."
058	Chair Miller	At this time I am seeking to change only the implementation date.

064	Chair Miller	MOTION: MOVED BY CONCEPTUAL AMENDMENT TO DELETE THE STAY- AT-HOME CREDIT IN THE CONFERENCE COMMITTEE AMENDMENT TO SB 2 A-ENG ADOPTED ON JUNE 23, 1999.
068	Chair Strobeck	"Based on the Senate floor vote on the conference committee amendments I would have to agree to the deletion. I still believe there is good policy reason behind the amendment."
082	Chair Miller	"I believe the Senate vote was more in reaction to the implementation date rather than the stay-at-home credit."

089	Sen. Hartung	Concur with comments made by Rep. Strobeck and Iím prepared to support the conceptual amendment.
091	VOTE	HEARING NO OBJECTION TO THE CONCEPTUAL AMENDMENT TO DELETE THE STAY-AT-HOME CREDIT, THE CHAIR SO ORDERED. (EXCUSED: REP. WELSH)
093	Chair Miller	The original Senate bill, as introduced, is now before the Conference Committee with an implementation date of January 1, 2001. Requested discussion.
099	Rep. Rosenbaum	The House floor overwhelmingly passed a different version of this measure. The measure now before the Conference Committee is a non-refundable credit that will not be effective until 2001 that will not help the people that the House was looking to help. "It seems to me that we are basically offering some relief, but taking it back in the next breath and I could not support it."
108	Chair Miller	Many of us would prefer an earlier implementation date, but it is my understanding that with an earlier implementation date it would not make it all the way through the process and be enacted as law.
114	Rep. Rosenbaum	It is my understanding that the non-refundable credit will not make it all the way through the process and be enacted as law.
118	Chair Miller	Recessed until 9:23 a.m.
118	Chair Miller	Reconvened at 9:23 a.m., extended recess until 12:10 p.m.
119	Chair Miller	Reconvened at 12:10 p.m. All present, except Rep. Rosenbaum, excused.

138 Sen. Dukes Noted for the record that particular credit is discriminatory towards single parents who might be able to stay at home with their children, if they had access to this credit. Single-parent families are families and this legislature has always recognized that; this is a poor way to do tax policy.
