Also, the position of Commissioner of Community Colleges was established. In 1989, there were further amendments to the law which stated that the commissioner was responsible for community college matters. Also, the OCCS was separated out within the DOE. In 1991, the community college support fund was established. This further clarified that the OCCS had the authority to work with the federal government. The OCCS were no longer employees of the DOE. The sunset clauses were extended to June 30th of 1993. In 1993, all of the sunset clauses were repealed. |
