300	Chair Bryant	What is an amphetamine?
302	Lemman	It is a precursor or by product of methamphetamine.
322	Counsel Taylor	Discusses ORS 475.996 statutes relating to drug offenses.
328	Lemman	Asserts that referencing ORS 475.996 in HB 3110B is not necessary.
343	Sen. Duncan	Currently, judges have discretion in sentencing drug offenders. Whatis wrong with that?
348	Lemman	Explains that HB 3110B increases the legal amount of drugs subject to criminal prosecution.
364	Sen. Duncan	Do judges support HB 3110B?
365	Lemman	I donít know.
370	Sen. Burdick	Do judges sentence drug offenders to probation in order to pursue drug treatment?
