044	Neeley	<ul> <li>Spoke to two issues faced by welfare to work clients as they enter the job market:</li> <li>1. Even with the substantial jump in spendable income for families leaving welfare it is difficult to maintain the low-wage jobs at that income level. Any unsuspected expense jeopardizes that job.</li> <li>As hourly wage increases, especially in the child care area, spendable income actually decreases.</li> </ul>

		SB 1190 would cost approximately \$18 million to make the EIC refundable and \$24 million for the working family credit. SB 2 would cost approximately \$17 million to make the EIC refundable and \$28 million for the working family credit.
		The costs are fairly close, but one bill doesn't give the benefits to the lowest income people and the other that gives it to the lowest income people helps the Adult and Family Services Division to meet their maintenance-of-effort requirement.
