## WORK SESSION ON HB 2128

- 023Sen. ShannonPresented amendment HB 2128-1 containing language requiring 2 cents per gallon of<br/>gas tax and an equal amount of registration, truck fees, and weight/diesel tax to pay<br/>principal and interest on bonds. The remainder of the State Highway Fund allows<br/>ODOT to keep 50%, the cities 30%, and the counties receive 20%. Exhibit 1
- 27 Sen. Shannon Clarified the HB 2128-1 amendment contains no gas tax increase.

32	Sen. Wilde	Questioned if the distribution formula to local governments was based solely on the registrations in the area or the number of miles maintained.
035	Sen. Shannon	Clarified the cities and counties will have a nice increase, however, she did not know if it was based on miles.
048	Sen. Wilde	Expressed what he termed as grave reservations with the distribution based solely on registrations because most proceeds go to Portland and very little goes to rural areas.
050	Sen. Wilde	Clarified that he would give a courtesy vote to move the bill out of committee, however, he will oppose HB 2128 as amended on the Senate floor.
