208	Chair Starr	Explains, during a salmon run, seals would follow the run up to 100 miles inland, feeding on the run. Asks if Barth has knowledge of this type of occurrence.

214	Barth	States he has no knowledge of that because the coastal streams he is familiar with do not run that far north. States the issue is difficult to solve because seals and sea lions are protected species.
228	Chair Starr	States the National Marine Fisheries are apprehensive about the seals and sea lions, and the effect the animals will have, while working for the recovery of the salmon species.
