270	Sen. Hannon	Answers that he has no polling figures but the voters should see the need for additional policing on the highways.
287	Bill Penhollow	Association of Oregon Counties (AOC). Testifies in opposition to SJR 11 because the bill opens up the highway trust fund to other uses. Notes that the AOC acknowledges the need for additional police.
318	Sen. Castillo	Asks if the issue is that the available funds are inadequate.
320	Penhollow	Responds that the counties face a shortfall of \$500 million in unmet highway maintenance and are concerned about the diversion of funds.
351	Sen. Hannon	Notes that both the state police and parks have experienced declining revenue in the past 19 years.
383	Penhollow	Answers that the AOC representatives from the sheriffis association also oppose SJR 11.
419	Sen. Dukes	Asks if the AOC could support the ñ1 amendments.
421	Penhollow	Responds that the ñ 1 amendments are narrow with regard to raising revenue.
