148	Addington	Mentions new allocations. States that it would increase flexibility in the program and that it would allow more cities to meet their infrastructure needs by increasing grant amounts. Explains that it is not a request for additional funds.
179	Chair Hill	Asks for the reasons for raising the population requirement.
183	Addington	Passes out hand-outs on population (EXHIBITS B and C). Explains the effects of changing the population requirements.
208	Chair Hill	Asks about the issue of ordinance versus resolution.
215	Addington	Outlines differences between an ordinance and a resolution (EXHIBIT D).
