011	Joe Gilliam	bill protects employers from inappropriate audits by insurers with respect to workers' compensation insurance reclassification. Supports HB 2893.
110	Nicola Cribb	Represents NFIB  Supports HB 2893. Submits written testimony of Richard Hill, Beaverton florist (EXHIBIT B). Describes incidence of his insurer retroactively reclassifying five of his employees at a cost of \$2,000.
129	Chair Harper	Asks name of insurance company.
130	Gilliam	Answers SAIF Corporation.
132	Rep. Fahey	Asks how insurer would prove "intentional" misreporting workers.
