010 Jack Kane Reviewed HB 3140 -3 (EXHIBIT A). Amendments state, in order for an optometrist to obtain rural tax credit, s/he must either obtain consulting privileges with a hospital or. In case of "frontier or remote rural" practitioner, s/he does not have to qualify.
