048	Rep. Markham	Didn't we make a run at a similar bill previously.
051	Davidson	Explains similar bill was in front of legislature last session, and was not adopted.
054	Courtney	Didn't die in our rules committee.
055	Chair Snodgrass	How much would the \$25 raise for your county.
058	Davidson	It would depend on who would file.
059	Chair Snodgrass	Let's assume the existing number continued.
061	Davidson	Responds that his county had 300-some file.
064	Chair Snodgrass	Has a concern that one side would be burdened at any one time with the costs, but understands that both sides go through process the same way.

075	Davidson	The bill requires if there is only one person that files, that person is declared elected.
