Adds there is also an issue of the up-front cost; there is an attorney general opinion saying that the Highway Trust Fund cannot pay any of the up-front costs, and this provides a process to go through. Comments further that the bill should go to Ways and Means so the up-front costs can be filled in, and that the -A11 amendments include all amendments (EXHIBIT D).
