030	Ken Husby	Deputy Director and Chief Engineer. Two types of landslide, one you can fix, one you can name. Water and gravity are the causes of landslides. Overview of landslides. Slides happen in catastrophic, or geology. Our problem is when they collide with highways. We currently do provide safety road patrols. We expect for the next decade, increased rainfall. Prevention and more attention if we disturb the earth. Mentioned all the ways that ODOT prevents water retention and saturation.
115	Husby	Continued presentation. Success of Major construction, Arizona Inn section Gold Beach, closed 101, innovative approach. Developed a drainage system. Have lowered the water table 100 feet.

110	Penhollow	Not aware of any restoration fund available at this time.
115	Rep. Josi	He is working with Myra Lee, legislation that will establish a fund Background one of the reasons that FEMA is reluctant is because Oregon does not have an established Disaster Fund. Perhaps if we can get this type of fund established FEMA will not be so reluctant to help.
130	Rep. Lokan	Questioned whether the Governor has allotted any monies to this year's budget for such a fund?
135	Penhollow	Nothing in budget at this time.
153'	Jerry Dove	Commissioner of Tillamook County. Comments on the \$5.5 million damage in public works department. \$2.9 million budget. FEMA waiver, still pushing on it. President has not yet made a commitment for the waiver in the State of Oregon. Tillamook County stated need to get a local fund. \$5.5 million damage, \$800,000 received for damages. Oregon has had a wake-up call to prepare for planning for future floods. A fund is needed locally.
206	Jon Oshel	Public Works Department Director. From a small agency's prospective, still trying to work their problems from last year's floods. (EXHIBIT D). The damages last February storm. \$5.2 million damages, with a \$2.9 million dollar road department budget.

328	Rep. Markham	Questioned whether the FEMA staff actually helped, or if congressmen were aware of these problems.

Tape 3- SideB 030	Oshel	There is something this committee could do. A joint resolution to Congress . Two comments, with these delays in payment, radically delays repairs. Tillamook hole, what happens when you have this money not coming in? The answer is things we just didn't do, no paving this year. No choice. This is a problem that needs to be addressed.
066	Dave Barenberg	 Senior Staff Assistant, League of Oregon Cities. The counties are the agencies that compile most of the information. Appreciation was voiced both to counties and ODOT. Some of the things you don't see are the underlying road damage from flooding. With the water seepage, reduces the life of roads. Our roads will not last as long as they should. What it does to budgets. 1. it eats up modernization 2. what it shows us is we need to make significant improvements to reseal future disasters. Weather forecaster's long term predictions are for a pattern of more rain for the foreseeable future. We need to plan for this. The positive of these disasters was the community pulling together to sandbag etc.
