064	Rep. Josi	Explains that ODOT can send a form to a person whose records are being requested; If that person signs it, that would allow DMV to disclose private records.
078	Adkins	States it would be a Class A misdemeanor for violations. Continues explanation.
108	Adkins	Explains if a person legally obtains records from DMV, those records cannot be redistributed.

130	Rep. Josi	Reiterates what Adkins said.
134	Adkins	Explains that a driver license applicant can opt to have their name withheld from bulk mail solicitor requesters.
151	Chair Montgomery	Thanks Adkins, Rep. Lokan, and Rep. Ross for their participation putting together the -11 amendments.

186	Rep. Josi	Explains what his work group did, who was there, and how they did it. States that his concern was to keep "crazy Fred" from being able to obtain DMV records (EXHIBIT E).

230	Rep. Ross	Explains how legitimate businesses use the DMV records and how they need to be accommodated. Explains her support of DMV and the -11 amendments.
254	Rep. Jane Lokan	District 25, states her agreement with Rep. Josi and Rep. Ross. Explains that DMV is not the only method to obtain private records.
274	Chair Montgomery	Explains that some groups of people still feel they need to be included on the list to obtain records.
305	Bill Seely	DMV, explains that DMV needs to be sure who they are revealing the private records to and who is eligible to receive them.
350	Seely	Explains the renewal process for driver's licenses and vehicle registration and how highly automated it is.
370	Chair Montgomery	Asks how DMV blocks records.
382	Seely	Responds how the records are blocked and that they are printed from microfilm.
405	Rep. Josi	Asks about bulk mailers being able to obtain DMV records.
