015	Mark Volmert	Gives background on -5 and -6 amendments to SB 196.
	Bob	Gives explanation of public input opportunities in SB 196. Says local government would amend their program, not Land Conservation and Development Commission (LCDC) or the Director. LCDC or the Director are in a position of approving or not approving the amendment. SB 196 would be

026	Rindy	neutral on how that occurs locally. What SB 196 would change is that the Director may approve the modifications, if local government asks the Director to do so. That is appealable to LCDC who then conducts the hearing the same as now.
039	Rindy	LCDC gives notice of their actions. Anyone asking to be notified of LCDC actions is sent the notice by the department. The same would be done by the Director if this is authorized.
057	Art Schlack	Association of Oregon Counties (AOC), comments on line 13, engrossed, "removes orderly implementation of work tasks." Says -5 amendments are preferred.
070	Chair Ferrioli	Asks if B-5 amendments are preferable.
080	Jon Chandler	Says either -5 or -6 amendments are acceptable.
085	Chair Ferrioli	Asks for any further discussion on these amendments. Hearing none, the chair will consider the -5 amendments.
094	Rep. Luke	MOTION: Moves to ADOPT SB 196 -5 amendments dated 6/27/97.
