TAPE 1, A

004 Chair Stull Calls the meeting to order at 5:10 p.m., 711197, and opens a work session on SB 229. SB 229 WORK SESSION

016 Chair Stull Indicates that the committee will reconvene at 9:00 a.m., 7/2197, to deal
with amendments to the bill.
037 Chair Stull Recesses the work session at 5:14 p.m.
038 Chair Stull Reconvenes the meeting at 9:25 a.m., 712197.
045 Phillip Lemman Representative, Criminal Justice Commission.

Explains that one interim has passed since the creation of the Commission, and the only thing they have done is issue a report of felony sentencing practices for 1994. Indicates that other duties of the commission include providing staff support for the asset forfeiture oversight committee. In terms of sentencing guidelines, the commission must include new crimes approved by the legislature into the sentencing guidelines. Explains that if the provisions of SB 229 don't pass, then the crime seriousness rankings must be made individually.

091 Chair Stull Asks how crime seriousness rankings are occurring now and what the

time frame is.

097 Lemman Describes how the 7 member Criminal Justice Commission was created

during the 1995 legislative session, to replace the 24 person Criminal Justice Council. Explains that the Council had the authority to rank crime seriousness that SB 229 would give to the Commission. Commission makes.

118 Rep. Eighmey Asks for clarification on what the difference is between the House and Senate bills. 123 Lemman Explains that the Senate did not include provisions that would allow the - commission to have interim rule-making authority. Without the conference committee amendments, new crimes would not be incorporated into the sentencing guidelines process until the next legislative session. The House amendments would allow the Commission to incorporate changes in their guidelines. Indicates that the commission would have a deadline of November 4 to incorporate new crimes into the guidelines. 150 Rep. Eighmey Verifies that the commission wants the authority to make the rankings but the deadline is in question 154 Lemman States that the deadline can definitely be met. 156 Chair Stull Asks how long it took to rank crimes and incorporate them into the guidelines after the 1995 session. 157 Lemman Indicates that there was no deadline for completion after the 1995 session, but after the 1993 session, changes were adopted in mid September. 163 Chair Stull Asks how long the process took after it was started in 1995 165 Lemman No more than two months 170 Sen. Trow Asks if the legislature has ever needed to make changes to the

commission's recommendations.

174 Lemman States that the commission incorporated about 40 felonies and misdemeanors and the Senate questioned three of them. **182 Rep.** Minnis Asks how complete an overview of the commission was presented to the House and Senate Judiciary committees. Asks if rationale for rankings were presented to the committees. 185 Lemman Indicates that written testimony was presented to the committees that discussed each crime and information was provided to the committees about discussions at the commission. Explains that another bill has been introduced that would require the commission to notify bill requesters of progress of the crimes in their bill. 212 Chair Stull Asks if it is the commission's intention to notify the committee only, of individual members and requesters. 221 Lemman Doesn't know for sure, but the committee would be not)fied and possibly the interested member. 225 Chair Stull Verifies that everyone assigned to the committee would be aware of the rule making progress. Asks what the mission of the commission is. 231 Lemman States that the primary purpose of the commission is to develop a long range public safety plan for Oregon. Indicates that a few steps have been taken to accomplish that goal. 235 Rep. Minnis Asks that Mr. Lemman restate his comment.

238 Rep. Minnis States that ORS 137.656describesthepurposesanddutiesofthe commission is to improve the effectiveness of state and local criminal

justice systems by providing an impartial forum for statewide policy development and planning.

244 Lemman Agrees that is the purpose of the commission, but the duty is to develop a state criminal justice policy and long range plan for a statewide criminal justice system.

250 Chair Stull Asks what initial steps have been taken to develop the plan.

253 Lemman Indicates that there has been an extensive briefing process because some members of the commission are true citizen members. Committees have been organized to make policy. The commission is not close to producing a draft policy.

275 Chair Stull Understands the council had 24 members. Asks how many members are

280 Chair Stull Asks if any of this session's bills that will be reviewed by the commission already have ranked crimes.

284 Lemman Indicates that SB 440, which deals with mail theft, already has a

ranking. Suggests that there might be others.

299 Rep. Minnis Expresses a lack of confidence in the Criminal Justice Commission.

Indicates that the commission is not mandated to provide fiscal

information for the legislature. Encourages the commission develop a

mathematical model to develop fiscal impacts.

368 Sen. Trow Indicates that there are many variables used in predicting fiscal impacts therefore a mathematical model would be a challenge to create.

380 Rep. Minnis Indicates that the model wouldn't have to provide final information, but it would have to create good estimates.

384 Rep. Eighmey Explains that a statistical model used for calculating fiscal impacts in the subcommittee on Ways and Means for Prison Populations was very

complex due to the number of variables involved.

003 Chair Stull Suggests that the committee recess and reconvene later in t'he day.

Agrees that it is the responsibility of the legislature to create good public

policy, and expresses frustration with not being able to collect data.

Understands that there is a fear of fiscal impact.

027 Rep. Minnis Asks for time to work with Mr. Lemman on t'he concepts. Suggests that it mig'ht not be possible to create a mathematical model that works.

037 Sen. Trow Does not object to trying to find a model, but cautions against trying to find a final solution. Stresses the importance of having the best information possible.

051 Sen. Trow Asks if it is possible to create a model.

053 Lemman Suggests that it is possible, but the complexity of the variables could

Minnis Indicates that discussions were held about creating calculation models. Indicates that the commission will be streamlining their process of creating fiscal statements. 143 Chair Stull Explains that changes were made to the bill by the House and there were concerns with the changes. 159 Lemman Discusses suggestions related to sunset and timeline provisions. 192 Chair Stull Asks if there is formal reporting of changes made by the commission. 195 Lemman Explains that all rules are submitted to the legislative counsel committee. 196 Rep. Minnis States that legislative counsel doesn't do anything. 200 Lemman Verifies that the question was whether the commission submits rules to anyone. 205 Sen. 241 Lemman Indicates that changes to that process were also discussed.

245 Sen. Qutub Asks if the current deadline is November 1.

249 Lemman Indicates that there is no deadline date. Explains that the deadline is to

391 Sen. Qutub MOTION: Moves SB 229 to the floor with the recommendation that the Senate and House concur in House amendments
dated 7/3/97 and repass the Measure.
395 Chair Stull Hearing no objections, declares the motion CARRIED.
