014	Sen. Kintigh	MOTION: Moves LC's: 1120, dated 8/20/96 and 1124, dated 7/8/96 BE INTRODUCED as committee bills.
	Chair Tarno	Hearing no objection, declares the motion CARRIED. (LC 1120 introduced as SB 432, LC 1124 introduced as SB 431.)
016	Chair Tarno	Explains that SB 207 will be rescheduled.
028	Mark Volmert	Committee Administrator, gives background on SB 196
<u>SB 196 - PUBLIC HEARING</u>		
041	Bob Rindy	Staff member, Division of Land Conservation and Development (DLCD), gives explanation of SB 196's impact on periodic review; work programs submitted by local government to update comprehensive plans; currently, local government cannot amend the program without LCDC's approval; allows director to approve change; adds criteria to aid director's approval of programs.
076	Sen. Ferrioli	Asks if this in response to a request by the jurisdiction or commission
088	Chair Tarno	Asks if this would ease the work of the department
090	Sen. Ferrioli	Explains his concern is that there is not more burden put on the community simply to assist the agency.
107	Sen. Ferrioli	Asks for an amendment to modify clause 1, section 1,
124	Sen. Fisher	Asks if the opportunity will be lost to the jurisdiction that wishes to make changes, will there still be an opportunity for appeal.
138	Rindy	Says appeal rights will still exist to LCDC.
147	Phillip Fell	League of Oregon Cities, speaks in support of SB 196. * rearrange work programs should be possible * amendment is supported Comments that in Portland, however, a work program for a large area may be reviewed and asks if someone outside of a local city could ask for review of a city's plan.

250	Sen. Ferrioli	MOTION: Moves SB 196 to the floor with a DO PASS recommendation.
251	Sen. Kintigh	Comments that it is a very simple change that can be passed, and the committee does not need to see the final Legislative Counsel version.
255	Chair Tarno	Says that as soon as the final version is received, it is approved to go to the floor. Asks if there is any further discussion on SB 196 as amended.
260	Chair Tarno	Hearing no objection, declares the motion CARRIED. VOTE: 7-0 SEN. BURDICK will lead discussion on the floor.
250	Chair Tarno	Adjourns meeting at 9:28 a.m.
