010	Mark Volmert	Committee Administrator, gives overview of SB 924-12, which incorporates -1,-2, and -3 amendments and the conceptual amendments made by the committee on Friday, March 7.

	Chair	Calls work session on SB 924; asks Senator Burdick her concerns about -3

039	Sen. Burdick	Refers to -3 amendments, wants more of a full hearing on these amendments
054	Sen. Burdick	MOTION: Moves to delete the -3 amendments in total from SB 924-1
055	Chair Tarno	Responds that those issues will be dealt with on the House side, considering the timeframe
074	Sen Kintigh	Asks about specific items in -3
075	Sen. Burdick	Comments on -3 amendments; indicates concerns about the make up of the scientific team; emphasis on land managers as opposed to scientific; management end is too heavy; more emphasis should be on the scientific end; indicates concerns about the temperature issue, mostly there are many changes and they need more review; a risk to jeopardize the salmon recovery program by keeping -3 amendments; the House can selectively introduce specific changes later

112	Chair Tarno	Says the concern is real and indicates Department of Environmental Quality (DEQ) should focus on the 21 coastal sub-basins; suggests the provision to sunset in two years, with an amendment in the House
125	Sen. Nelson	Concern about eastern Oregon Bull Trout and steelhead listing this summer; wants the sentence deleted regarding the emphasis on the 21 coastal sub-basins
132	Sen. Ferrioli	Original language leaves the practical side of management weak; need balance between pure science and the practical applications; eastern Oregon interest should be included; Senate version will be different from House version with a conference committee to reconcile the differences
156	Chair Tarno	Calls for a vote on the motion
