003      CHAIR REPINE: Calls the meeting to order at 4:20 pm.

            Opens WORK SESSION On SB1158

013      BILL TAYLOR, Legislative Counsel: SB1158 reduces the amount payable to the Oregon Racing Commission by Greyhound Race Meet Licensees from 3% of the gross mutual to 1.6%.

019      REP. BEYER: Do the fees all go to the Racing Commission?

- 022 CHAIR REPINE: They pass through to the General Fund.
- 023 REP. CARTER: Are these for future or present dollars?
- 026 CHAIR REPINE: The amount that is projected for the 1995-97 is still anticipated under the old percentage computations and that would create a loss to the current biennium if we went to the 1.6% amount.
- 030 MIKE STINSON, Fiscal Analyst: The December Revenue Forecast produced by DAS would have estimated revenues on the basis of existing laws therefore, any shift would come out of that estimate.
- 035 MOTION: REP. JONES moves SB1158 be sent to the Floor with a DO PASS recommendation.
- 036 VOTE: REP.'s BEYER, JONES, MONTGOMERY and REPINE vote AYE.  
REP. CARTER votes NO. The motion CARRIES.  
REP. JONES will lead discussion on the Floor.

- 044 TAYLOR: SB1159 clarifies that the requirements of the Federal Gun-Free Zone Act applies to school grounds, outings and events. Lists exemptions.
- 060 MOTION: REP. MONTGOMERY moves SB1159 be sent to the Floor with a DO PASS recommendation.
- 061 VOTE: REP.'s BEYER, JONES, MONTGOMERY and REPINE vote AYE.  
REP. CARTER votes NO. The motion CARRIES.  
REP. MONTGOMERY will lead discussion on the Floor.
- 064 Closes WORK SESSION on SB1159  
  
Opens WORK SESSION on SB1160A
- 065 TAYLOR: SB1160A prohibits a local government entity from imposing a tax upon the transfer of property unless the law imposing the tax was operative February 1, 1996 or unless the tax became effective on or before July 1, 1998.
- 070 REP. MONTGOMERY: I will vote yes here to get this out of Committee but I will be a firm no vote on the Floor. I do not support real estate transfer taxes or state mandates on local government.
- 075 MOTION: REP. MONTGOMERY moves SB1160A be sent to the Floor with a DO PASS recommendation.
- 078 VOTE: REP.'s REPINE, JONES and MONTGOMERY vote AYE.  
REP.'s CARTER and BEYER vote NO.  
REP. JONES will lead discussion on the Floor.

084 TAYLOR: SB1163 allows a grocery store to conduct sample tasting of beer and wine.

097 MOTION: REP. JONES moves SB1163 to the Floor with a DO PASS recommendation.

099 REP. CARTER: Is this truly a technical fix?

100 TAYLOR: Yes.

105 VOTE: CHAIR REPINE: Hearing no objection the motion CARRIES. All members are present.

110 TAYLOR: SB1164A clarifies a school district where an adult corrections facility is located must provide education to the juvenile offender placed within that facility. Would not apply to a juvenile in an adult correction facility serving time.

117 MOTION: REP. JONES: moves SB1164A be sent to the Floor with a DO PASS recommendation.

119 VOTE: CHAIR REPINE: Hearing no objection the motion CARRIES. All members are present.

REP. CARTER will lead discussion on the Floor.

124 TAYLOR: SB1165 clarifies guardianships and conservatorships commence prior to the effective date of January 1, 1996.

135 MOTION: REP. JONES moves SB1165 be sent to the Floor with a DO PASS recommendation.

138 VOTE: CHAIR REPINE: Hearing no objection the motion CARRIES. All members are present.

REP. BEYER will lead discussion on the Floor.

145 TAYLOR: SB1166 repeals ORS 678.395, SB771 of 1995 Session.

156 MOTION: REP. JONES: moves SB1166 be sent to the Floor with a DO PASS recommendation.

REP. CARTER votes NO. The motion CARRIES.

- 164 TAYLOR: SB1167 corrects an error contained in Chapter 332 of ORS in 1995 pertaining to permanent partial disability benefits.
- 171 MOTION: REP. JONES: Moves SB1167 be sent to the Floor with a DO PASS recommendation.
- 174 VOTE: REP.'s JONES, MONTGOMERY and REPINE vote AYE.  
REP.'s CARTER and BEYER vote NO. The motion CARRIES.  
REP. WATT will lead discussion on the Floor.
- 184 Closes WORK SESSION on SB1167  
  
Opens WORK SESSION on SB1168A  
  
TAYLOR: SB1168A allows a school district to request a criminal history records check of a newly hired employee who has direct unsupervised contact with children. Allows the school district to recover costs of check from employees.
- 191 REP. CARTER: Will the employees who have been there for a long time pay for the check?
- 195 TAYLOR: I thought teachers had to pay.
- 201 JIM GREEN, Oregon School Board Association: It does not require the employee to pay the cost, it allows the district if they choose to recoup that cost from the employee.
- 205 REP. CARTER: Is that true for people that have been there a long time?
- 206 GREEN: It would include them.
- 211 REP. BEYER: I thought it was just for newly hired employees.
- 216 GREEN: The requirement for fingerprint check was in 1995 HB2393. This is just for who pays for it.
- 220 MOTION: REP. JONES: Moves SB1168A to the Floor with a DO PASS recommendation.  
  
VOTE: REP.'s MONTGOMERY, REPINE and JONES vote AYE.  
REP.'s BEYER and CARTER vote NO. The motion CARRIES.  
REP. MONTGOMERY will lead discussion on the floor.
