On page 2 of SB 1059-1, lines 7 and 12, add "Pacific Fisheries Management Council" before the word management on both lines [EXHIBIT A]. Sen. Dwyer: Ask if we have the amendments in writing. SEN. Johnson: Clarifies. MOTION: SEN. JOHNSON: Moves amendments into SB 1059-1 amendments to 43 adopt the "Pacific Fisheries Management Council" phrase. VOTE: Hearing no objections, the amendments are ADOPTED. SEN. HARTUNG and SEN. SHANNON are excused. MOTION: SEN. JOHNSON: Moves the amended SB 1059-1 amendments into SB

1059.

60 Rod Ingram, Deputy Director, Oregon Department of Fish and Wildlife: Submits written testimony on HB 2568 [EXHIBIT C].

98 Sen. Johnson: Asks if there is any particular fund that only has money in it for most people who voted for Measure 18 that we could tap for this damage.

Sen. Dwyer: Intent of this bill was that people recognize the wildlife fund is paid for by hunters. It wasn't hunters that passed ballot Measure 18; it was the general population. Our philosophy is the general population

ought to support the damage.

115 Opens PUBLIC HEARING on HB 2868

Staff Measure Summary submitted on HB 2868 [EXHIBIT D].

125 Steve Lane, Oregon State Police: Submits testimony in support of HB 2868 [EXHIBIT E]. Reviews the law and its intent and explains the use of the wildlife decoy in apprehending violators.

163 Sen. Dwyer: Asks if the decoy is shot out of season or at night from the roadway, would that be a violation. Asks what the penalty would be.

Lane: Responds and clarifies. Closed season cited for taken deer in closed season; night time, cited for taking deer with the aid of an artificial light; shooting from the roadway in day time, cited under criminal statute for discharging a firearm from a public roadway, which is a violation and punishable by \$250. However, statute now comes under the wildlife statutes and make it a Class A misdemeanor--1 year or \$5000.

206 Sen. Johnson: What size antlers are put on the decoys?

Lane: Clarifies the procedures. Large set of antlers on the decoy out of season; during the season any where from spikes to three-points. The intent

is to go more after the out-of-season and the nighttime hunters.

221 Sen. Dwyer: Has anyone taken the decoys?

Lane: There was one problem in the Portland area when the decoy program was first started.

231 Ingram: Supports comments of Sgt. Lane. Submits written testimony in support of HB 2868 [EXHIBIT F].

238 Closes PUBLIC HEARING on HB 2868 Opens the WORK SESSION on HB 2868

240 MOTION: SEN. DWYER: Moves HB 2868 to floor with a DO PASS recommendation.

252 Opens WORK SESSION on SB 950

Staff Measure Summary submitted on SB 950 [EXHIBIT G].

270 Chris Durth, Governor's Office: Governor can support SB 950-3 amendments. The Governor's office met the bill's proponents and other interested parties in hopes of working out some language on these amendments that could get their support for them. They cannot accept these

amendments. Governor's office has made every effort to work with them and come up with something we can all agree with.

Sen. Dwyer: Asks about the SB 950-4 amendments.

Durth: Responds the SB 950-4 amendments just includes section G, lines 10 through 13 of the SB 950-3 amendments.

286 Tom Gallagher, American Plastics Council: SB 950-4 amendments are essentially the same as the SB 950-3 (G) in the SB 950-3. Only has the addition on line 5 of the numbers 178.522. This language was a compromise the American Plastics Council made in the Governor's office of the time agreed to for these to exempt from the Department of Transportation hazardous materials only those materials which were subject to these filing

Federal statutory provisions. They have to do with actual testing procedures DOT uses on the packaging. Well over 75% of the materials that were in the DOT are Xed out. Agrees with the Governor's amendments with the addition of that fourth statutory reference.

308 Chair Kintigh: Clarifies strike SB 950-3 (G) and substitute with SB 950-4 (G).

312 Terry Witt, Oregonians for Food and Shelter: [EXHIBIT O]. Cannot accept

the Governor's SB 950-3 amendments. Urge committee to reject SB 950-3 amendments because they fractionalize the regulatory field with respect to regulation of pesticides by differentiating one type of pesticide from another which is not done in the law. Urge passage of SB 950-1 amendments,

which deal with a straight FIFRA exclusion for all products registered and regulated by the EPA.

Chair Kintigh: Do you object to the SB 950-4 amendments?

Witt: Do not object to SB 950-4. Further puts Oregon's statutes in compliance with Federal law, and we wouldn't have any legal problems from a

FIFRA or U. S. DOT perspective with regard to containers.

392 Larry Edelman, Oregon Department of Justice: Explains there are no legal problems of splitting out the definition of agricultural pesticides from general pesticides. Our definition of agricultural pesticides comes from a proposed EPA regulation dealing with pesticide containers.

422 Bruce McIntosh: Provides written statement on behalf of John Matthews, Garten Foundation [EXHIBIT H]. Reads pertinent parts of testimony; clarifies plastic containers that meet the FIFRA definition not acceptable to Garten Foundation.
