UCHYTIL: Thinks that there are families that would be benefited by financial reimbursement -fiscal impact -in response to Fisher, this is d UCHYTTL: Catch 22 MEEK: Reviews chart (See: Exhibit I) TAPE 17, SIDE B UCHYTIL: Financial caution 035 SNODGRASS: Cash assistance received? UCHYTIL: Check and medical card 053 MEEK: Cost factors to consider include things such as child being placed under medical insurance, which is not allowed, or under the state' insurance 070 UHERBELAU: Could reduce fiscal if we could tap into more federal money UCHYTIL: Court orders UHERBELAU: Continues UCHYTIL: Federal reimbursement UHERBELAU: Why aren't we certifying all foster homes? See a problem when the parents are poor - isn't that the reason that children aren't UCHYTIL: ADC standards of "poor" FISHER: Amount of CSD payment to foster home? UCHYTIL: Refers to Exhibit I 120 -increased requirements also means increased staff time FISHER: Thinks we could spend time working this out and would be benefited by putting more time up front UCHYTIL: Much of what we are talking about is described in the law NANCY MILLER, CITIZENS REVIEW BOARD: Need to be careful not to muddy up the issue -if guardianship is granted CSD custody goes away as well as the federal dollars; therefore we are not dealing with all those regu MEEK: Need a major fiscal review of this PIERCY: Agrees UHERBELAU: Doesn't see this as being so simple, if I become the guardian of my niece, CSD is still involved; creating a whole diffe MILLER: I am suggesting that we make it simple, although this bill doesn't allow that simplicity TIMOTHY TRAVIS, JUVENILE RIGHTS PROJECT: It can be made simple -a guardianship should sever ties with CSD -cost of guardianship can FISHER: Would implementation of HB 2030 along with permanent guardianship create a neutral fiscal impact, up front costs equal long term sav TRAVIS: Thinks so, although doesn't have figures at this time MILNE: Also getting people to make their own decisions PIERCY: Who else, beside CSD, could be a different faucet for children? TRAVIS: Does not know TAPE 18, SIDE B EIGHMEY: CSD at least has some contact with the children and would then

be aware of sexual abuse, etc. within the quardian's home

MILLER: There are some cases that CSD would need to continue to be involved

-- those recommendations would be make by the courts, CSD, others - we are talking about those cases where there is no need for continued in

RICHMOND: Continues about funds -CSD workers' training -Oregon options -temporary agencies -with most of government going broke and being b to these business which are owned outright by architects, by a lot of the people that sponsor a lot of architects, of these different social

SANDRA SIPES: Doesn't want anybody's money, want my grandchildren -tells of her experiences with CSD and trying to remove her grand
