CHAIR MEEK: Calls the meeting to order at 8:37 am

Children's Services Division (CSD) Response - Informational

Staff submits a letter written to CSD, from committee members, to respond to at today's hearing (EXHIBIT A) and a letter from Clinton and Ti (EXHIBIT B)

021 KAY TORAN, ADMINISTRATOR, CSD: Responds that at yesterday's hearing it was requested that branch managers not administrators respon CHAIR MEEK: CSD responded yesterday to another legislative committee; re-caps incidences that occurred and discussion at yesterday's hearing 180 TORAN: In response to Meek, does not yet have the answer to why policies

and procedures were not followed; hope to get that information immediately -in response to Snodgrass, discusses what is the definition of sp rely on the definition of abuse -it is our procedure to talk to the parents first

SNODGRASS: How as a parent, do I know what my boundaries are - when it is O.K. to spank a child?

TORAN: We are concerned about injury to children, not the spanking of a child -a screener determines if an investigation needs to occur

SNODGRASS: Afraid where were we are going with the definition of abuse

TORAN: Discusses the need to define corporal punishment

303 UHERBELAU: Advises committee to move slowly in defining corporal punishment

TORAN: NeigHB or made call to Sheriff's department, who then responded -neigHB or indicated that this was a long standing problem 360 -in TAPE 30, SIDE A

-in response to Eighmey, 25,000 cases of abuse are reported each year, 25 percent result in removal

DIANA ROBERTS, CSD: Discusses infrequency of improper removal

TORAN: Police report -would have followed our recommended steps in this case -relative resources -have not received a full release for the W

075 CHAIR MEEK: The Whiteheads are working with the department and are working through issues; felt it would be best that they not appea EIGHMEY: Disturbed that we are discussing this without full information or full participation by parties -if I would have read this police r 170 CHAIR MEEK: Statutes do define abuse; what CSD is asking for is a definition of corporal punishment

180 FISHER: Each family is different, each is not perfect -would like to know what your definition of injury is -suggests placing emplo TORAN: We are required to do investigations when an employee does not perform according to standards -reads policy which describes physical CHAIR MEEK: Everybody is in agreement that CSD should have followed up on this case -we are here to deal with procedural issues

337 REP. JOHN SCHOON, DISTRICT 34: Discusses situation that occurred in Polk

County which was very similar to the Whitehead case -feels that Toran truly looks out for the best interest of the children -considered an " in the house or if you are a single parent

TAPE 29, SIDE B CHAIR MEEK: Child abuse risk factor (See: Exhibit C)

SCHOON: Feels that children being raised in single parent home should not be identified as "at-risk"

UHERBELAU: Are release forms available so that we can have access to CSD records?

TORAN: Yes

UHERBELAU: Have heard a lot of testimony against CSD, would like to have those folks sign release forms so that we can have needed informat CHAIR MEEK: Have requested staff to look into that

077 MILNE: After numerous calls to CSD, I have yet to see one document although release forms have been signed -need better communicatio 100 SNODGRASS: Cowering; subjective to person's opinion

TORAN: Police officers make judgment calls, see a lot of situations

SNODGRASS: Officers may make assumptions without thorough investigation TORAN: Suggests bringing in law enforcement to see how they work EIGHMEY: CSD based their action on a police report; shouldn't be chastising CSD for responding to a police report MEEK: CAMI funds available for multidisciplinary teams to assess situations -refers to definitions of abuse (See: Exhibit C) TORAN: This is a gray area -if same behavior happened between two adults there would an assault and battery charge 214 ROBERTS: In response to Fisher, discusses statistics -parents are usually upset and disagree with action when removal occurs, do no 240 REP. MARGARET CARTER, DISTRICT 18: Talks about being a mother of nine children -overwhelming to have a large number of small child UHERBELAU: Previous generations had supportive communities, which we don't have now 325 CHAIR MEEK: Thanks Toran -why didn't judge question CSD about details prior to issuing order? TORAN: Can't speak for the judge -they look at CSD as the professionals PIERCY: Comments on parents job and CSD's job 400 TAPE 30, SIDE B FISHER: Do you believe these children would be back in the home if it weren't for the legislature's involvement in this case? TORAN: Cannot answer that CHAIR MEEK: The amendments for HB 2356 are not ready, will re-schedule hearing HB 2029 - Work Session MANN: Updates on HB 2029-1 proposed amendments (SEE: Exhibit B from 2/21/95) CHAIR MEEK: The intent of adopting the -1 proposed amendment is then to form a work group to draft suggested changes to the amendments MOTION: PIERCY MOVES THE ADOPTION OF HB 2029-1 PROPOSED AMENDMENTS VOTE: NO OBJECTIONS CHAIR MEEK: Asks Uherbelau and Snodgrass to work on confidentiality issue HB 2029 - Public Hearing ROBERT JOHNSON, ATTORNEY & PARENT: Testifies on HB 2029 -talks about a case he was involved with CSD -would like to see greater ac 100 BETTY UCHYTIL, CSD: Will look into that MARVA NICKA, GRANDPARENT: Testifies on HB 2029 -CSD does not follow their procedures 290 325 AMY HEWITT, PARENT: Testifies on HB 2029 -talks about her involvement with CSD -scared of repercussions -there is no CSD accountabi UCHYTIL: There are 25,000 referrals that require an assessment -there are 8,000 founded child abuse incidents -approximate 25 percent remov CHAIR MEEK: Asks Uchityl to provide Washington County report when available -would like number of petitions UCHYTIL: Can ask but that is court information CHAIR MEEK: Would like to know how may petitions have transpired TAPE 31, SIDE A UCHYTIL: We may sign a petition that does not require removal, it would require a court hearing and an appearance to come to court -what we MEEK: Yes, that also FISHER: Would like to know how may CSD workers have been disciplined in the past year and what the discipline action were by category CHAIR MEEK: Adjourns the meeting at 10:30 a.m. 030 Submitted by, Reviewed by,
