230 MILNE: Submits and explains HB 2356-3 proposed amendments (EXHIBIT C) -disclosure

CHAIR MEEK: In response to Uherbelau, discusses disclaimer

MILNE: In response to Eighmey, talks about teen mothers

UHERBELAU: Should add language that says emancipated minors

EIGHMEY: Suggests language

356 MILNE: Intent needs to be clear that intake assessment will occur

PIERCY: This doesn't make it sound optional

CHAIR MEEK: Clarifies

MOTION: REP. MILNE MOVES ADOPTION OF THE HB 2356 -3 PROPOSED AMENDMENTS

UHERBELAU: Concerned about language; will be left up to judges to interpret intent

155 LT. CLIFF DAIMLER: OREGON STATE POLICE: From our perspective there is no fiscal impact on HB 2604

166 BETTY UCHYTIL, CSD: Spoke to Attorney Generals office about an easier way to accomplish this -as the bill is written it probably would have suggested language on how to do this in an easier manner -explains another way to accomplish goal without adding additional response

197 RON WEISE: Testifies on HB 2604 -talks about his experience with CSD and his grandchildren
