The Preliminary Staff Measure Summary is hereby made a part of these Minutes (EXHIBIT D). REP. TONY CORCORAN (D - District 44): Submits prepared statement regarding HB 3284 (EXHIBIT H).

130 CHAIR TIERNAN: Provides background history about the bill, particularly

that Rep. Federici does not want to pursue the bill. Explains intent to proceed on the bill.

152 REP. LEHMAN: Clarifies that what goes on the driver's license now and the problem addressed by Rep. Federici is that driver's licenses were being

used as "proof of citizenship." The proposed language for driver's licenses "is not proof of citizenship."

CHAIR TIERNAN: Explains the policies of other countries is to accept a driver's license as the only acceptable identification that is proof of U. S. citizenship. If the solution suggested is adopted by DMV, Oregon would be the only state in the nation with a driver's license that reads "could not be used for proof of citizenship." However, a driver's license and a voter registration card are deemed to be absolute proof of legal residency in the United States and that person will be allowed to return to this country. Opines "this answer is anything except creating a huge problem and I don't think we should penalize all Oregonians, because of a problem that perhaps we either do or do not want to address by penalizing all of them with a stamp on their driver's license that's going to penalize them."

 $\ensuremath{\mathsf{CHAIR}}$ TIERNAN: Comments about the bill's sponsor asking to have the bill withdrawn.

198 REP. TONY FEDERICI (D -District 1): Testifies on HB 3284. Reads from prepared testimony. Submits (EXHIBIT E).

240 REP. JOHNSTON: Respectfully requests the Chair remove the names of the sponsor and other signators of the bill before presenting it for consideration as a Committee bill.

CHAIR TIERNAN: Does not oppose someone being removed as a sponsor of a bill; however, there is a process through the Chief Clerk of the House.

263 REP. JOHNSTON: Recounts discussion with the Chief Clerk of the House.

REP. WYLIE: Offers to leave her name on the bill if it is used as a vehicle that solves the problem that the Governor's action doesn't solve.

284 CHAIR TIERNAN: Suggests for the sake of efficiency to hold a public hearing on the bill, then bring back the bill with an opportunity to consider it.

308 $\,$ REP. MARKHAM: Unaware of whether or not DMV has the appropriate authority.

REP. HAYDEN: Reads from the Staff Measure Summary about an eight percent decrease in the issuance of licenses. Opines that eight percent of Oregon drivers are not now legally in Oregon. Supports a hearing on the bill.

332 KELLY TAYLOR, DMV Legislative Coordinator, DMV Services (ODOT): Testifies from prepared testimony on HB 3284. Submits (EXHIBIT F). > Introduction.

340 > Talks about affect on DMV.

REP. ROBERTS: Is this for an original driver's license rather than a renewal?

MS. TAYLOR: The bill amends a statute that talks about eligibility for a license. It says that the department shall not grant privileges. DMV, in addition to contacting other states for statistics, took a very conservative approach on the fiscal and the implementation plan. If it is part of the eligibility, technically that would mean "any applicant and that's original, renewal, duplicate, motorcycle endorsement. Anybody, learner permit, coming in for driving privileges would not be eligible until they had done this proof." Reviews DMV's work on the fiscal.

378 REP. ROBERTS: Of concern is the perception of what appears to be harassment of our own citizens (i.e., requiring proof of citizenship to renew a license).

MS. TAYLOR: It is possible that DMV may have already issued a license that shouldn't have been issued. The statute targeted for amendment is "eligibility for a license" and that means "privilege"; therefore, DMV would have to recheck all those previously issued.

REP. ROBERTS: In other words, an applicant for renewal would have to submit a birth certificate.

MS. TAYLOR: That's correct.

395 CHAIR TIERNAN: Comments about the importance of the procedures DMV is using currently.

401 MS. TAYLOR: Continues presentation regarding the affect on DMV.

CHAIR TIERNAN: Gives an example of an applicant who did not have a prior driver's license in Oregon, was not a lawful Oregon driver and was without identification except for a PGE bill, but the Salem DMV office issued a driver's license. Is that DMV's proper procedure?

MS. TAYLOR: A PGE bill would not be acceptable documentation of age. It would be appropriate identification for the residence address; therefore, if it was merely a change of address for someone with a license already, that could be used to issue a duplicate with the new address.

CHAIR TIERNAN: Continues to inquire about DMV procedures.

TAPE 91, A

029 REP. JOHNSTON: Would a birth certificate from the State of Mechuacan, Mexico, be sufficient proof?

MS. TAYLOR: It would for date of birth. Continues presentation. > Specifies other evidences of identity and the results from contacts with other states.

> Fiscal analysis review.

> DMV concerns.

078 REP. HAYDEN: What would prove for the purposes of this bill that they are a U. S. citizen -- a birth certificate, passport or INS documents?

MS. TAYLOR: Yes.

REP. HAYDEN: Continues to inquire about what constitutes proof of citizenship.

106 CHAIR TIERNAN: Do you have an estimate of how many driver's licenses DMV may have issued to illegal aliens?

 $\operatorname{MS.}$ TAYLOR: No statistics. Refers to statistics from the State of California.

CHAIR TIERNAN: Continues to inquire about California's statistics and what

a 12 percent decrease in driver's licenses would do to DMV's budget if the bill is passed?

117 $\,$ MS. TAYLOR: The net decrease is eight percent and that is the basis of the fiscal.

CHAIR TIERNAN: When is it a requirement that someone visit DMV for a driver's license (e.g., when it expires and a new picture is taken)? Is it

required that someone visit DMV every three years or so?

 $\mbox{MS. TAYLOR:}$ Once someone has a driver's license, the renewal is on a four-year cycle. Every other renewal cycle there is the option of renewing

by mail and receiving the sticker (i.e., it may be eight years from the last photo) or someone may visit DMV every four years for a new photo.

131 REP. MARKHAM: Does the Governor have the authority to require specific language be printed on a driver's license?

MS. TAYLOR: Recounts the discussion at the Governor's office and with Rep.

Federici.

REP. MARKHAM: Continues inquiry about rulemaking authority.

162 REP. HAYDEN: Suggests not having the statement on licenses of "not proof of citizenship".

 $\ensuremath{\,{\rm MS}}\xspace$. TAYLOR: DMV was asked whether or not it could be done and what would be the cost.

 $\ensuremath{\mathsf{CHAIR}}$ TIERNAN: Seeks further information from the discussion at the Governor's office.

180 REP. ROSS: Refers to testimony about traffic safety. It seems one of the effects on the public would be financial problems involving an accident

with an uninsured driver. Provides example and requests comments.

195 MS. TAYLOR: That is DMV's concern.

CHAIR TIERNAN: Are you saying that an illegal alien with a driver's license has insurance?

 $\ensuremath{\,^{\rm MS.}}$ TAYLOR: If someone is denied a license, they will not be able to get insurance.

CHAIR TIERNAN: DMV has no idea how many illegal aliens have driver's licenses or how many are uninsured?

MS. TAYLOR: That's correct. DMV does not maintain statistics on how many people have illegal driver's licenses.

211 REP. STROBECK: Refers to testimony about immigration papers being accepted to obtain a driver's license. Does that mean that someone in this

state on a work permit and who is not a citizen can get a driver's license in Oregon?

 $\ensuremath{\,^{\rm MS.}}$ TAYLOR: Lawful presence would be if someone is on a visa. They would be able to obtain a license.

REP. STROBECK: Continues inquiry about people who have a visa and a driver's license.

226 REP. HAYDEN: Offers that Oregon could resort to an international driver's license system. What is the probable incidence of people driving in Oregon who have "no fault" insurance or uninsured motorist's insurance?

MS. TAYLOR: DMV has no available statistics.

255 REP. LEHMAN: Would it be safe to say that the two primary purposes of issuing a driver's license are (1) a means of identifying that person and (2) the person has shown the requisite skills to operate a vehicle in the State of Oregon?

MS. TAYLOR: Yes.

REP. LEHMAN: Adding a disclaimer about "what this license is not" doesn't take away from that primary purpose.

MS. TAYLOR: No, because today the license is not proof of citizenship.

273 REP. JOHNSTON: Refers to previous discussion of uninsured drivers. Is it correct that if this bill is passed, that it will be impossible for this

eight percent group to become insured?

MS. TAYLOR: That is correct. Continues discussion about uninsured drivers, licensing requirements and identification issues.

384 REP. TIERNAN: Refers to discussion with the Oregon State Police. There

are no statistics about leaving the scene of an accident and the speculation that perhaps they were uninsured. Provides an account of the State Police officer in Klamath Falls who was shot and killed -- one of the

illegal aliens involved had an Oregon driver's license. Comments about whether or not Oregon promotes driving without insurance when driver's licenses are issued to illegal aliens as well as it gives them a means of providing false documentation to Oregon's employers to gain employment.

429 REP. LEHMAN: Refers to analogy and conclusion. Suggests that instead of language on licenses that reads "not a proof of citizenship", but rather

the language "could be dangerous". Opines that it is "absurd to draw the conclusion that giving someone a driver's license is some indication that they are going to shoot somebody."

CHAIR TIERNAN: The point is that if you are an illegal alien, you perhaps do not want to be caught by the law and there is that risk when confronted by law enforcement authority.

TAPE 90, B

015 REP. STROBECK: Is it correct that DMV is not obligated to issue a license just because someone visits the office (i.e., it is not a right of citizenship)?

 $\ensuremath{\,^{\rm MS.}}$ TAYLOR: No, it is a privilege to drive in the State of Oregon and possess a driver's license.

019 REP. HAYDEN: Isn't it correct that an applicant must accomplish certain

proofs of proficiency, knowledge, identification, etc. in order to possess a driver's license? Doesn't the language in the bill state that an applicant must undergo specific steps, one of which is proof of citizenship?

MS. TAYLOR: That's correct. The fourth requirement is documentation of age, name, residence and now lawful presence.

044 ROBERT W. DONALDSON (Salem), a lawyer specializing in immigration law. Testifies as a concerned citizen and concerns about how the bill would affect clients:

> Provides background of law practice and personal credentials. > Represents primarily businesses/clients who are legal aliens (i.e., people who are trying to come into the country to provide a variety of services) - rarely represents illegal aliens. 069 > Identifies issues of concern and lists people here lawfully.

120 > Gives conclusion about the bill, that it may have a more far reaching effect than contemplated.

151 CHAIR TIERNAN: Knows there are many states, including the District of Columbia, that have such requirements and the program is working without too much problem. Why is that, or are they making a lot of mistakes?

MR. DONALDSON: Doesn't have specifics about the twelve states cited; however, says that feedback from the American Immigration Lawyers Association, if statistics are available, could be obtained/presented to the Committee.

172 REP. JOHNSTON: Refers to testimony about some clients who might have difficulty proving legal status. Consequently, if the law passed, they would have problems driving. Do you feel this would have negative, commercial effect on the state's flow of commerce if the bill is passed?

MR. DONALDSON: Think so. Many clients are investors (i.e., those who invest small amounts of \$100,000-\$200,000 and those who invest \$1 million or more). Opines that if someone from a Korean or Japanese country came over here and started up a plant or invested \$1 million in a business and because there was some slowness in getting the final approval of the Immigration Service in Lincoln, Nebraska, they would be irritated if they couldn't be driving.

197 REP. STROBECK: What do you think about the concept of having every driver's license state "not proof of citizenship"?

MR. DONALDSON: The notation on the driver's license would not be well received by the general public and, as a matter of immigration law, doubts it will make any difference. Doubts such a notation would be useful. Citizenship is a function of and should be the responsibility of the federal government -- the problem is a federal rather than state problem.

255 ROBERT TINDELL: Urges a tightening of the Oregon driver's license requirements, because it is used too widely for identification. Does not object to proof of citizenship periodically to renew a driver's license.

277 CELIA NUNEZ-BREWSTER, Acting Executive Director, Commission on Hispanic Affairs: Testifies from prepared testimony in opposition to HB 3284. Submits (EXHIBIT G). > Explains that the statute is not good public policy; it provides for discriminatory action. > Reviews the lack of statistics about the issuance of driver's licenses to

non-citizens, concern about noninsurance and accidents, allegations about the driver's license as a proof of citizenship, and insinuations that possession of a driver's license establishes legal residency and the potential public social services. 315 > Summary statement.

335 DAVID J. FIDANQUE, Executive Director, American Civil Liberties Union of Oregon: Testifies in opposition to HB 3284. > States there are a number of lawful residents of Oregon who oftentimes do

not have documentation. Provides examples. \$> Opines that an illegal alien in Oregon has nothing to lose (i.e., they can get around this); however, it is lawful people who will be hurt by the proposed legislation.

REP. MARKHAM: If, in fact, Proposition 187 in California that is in the 384

federal courts prevails, do you feel that the State of Oregon will have an influx of illegal aliens?

MR. FIDANQUE: Doesn't know. Opines that if that is the result of the legislation, there will be federal legislation very quickly dealing with all of those issues.

390 MS. NUNEZ-BREWSTER: Doesn't know whether or not there would be a large influx of Californians in Oregon if an Oregon version of California's Proposition 187 passed. Is aware of the Federal Human Rights Act proposed in Washington, D.C., regarding the issue.

REP. GRISHAM: Requests a definition of "illegal alien"? 427

MR. FIDANQUE: Generally, the term "illegal alien" refers to people who are

not authorized to be in the country (e.g., individuals who entered the country illegally or individuals who entered the country legally, but did not leave when required by a visa or other documents).

449 CHAIR TIERNAN: Is it your position that illegal aliens should be entitled to possess an Oregon driver's license?

MS. NUNEZ-BREWSTER: Opines, as a citizen, that it would be best to leave the requirement as "general rather than racial". Prefers that anyone on our streets or highways have a driver's license issued in order to obtain insurance.

CHAIR TIERNAN: Is it your position, assuming every person who is white is an illegal alien, should have the right to have an Oregon driver's license?

MS. NUNEZ-BREWSTER: The question is too broad to answer "yes" or "no".

480 CHAIR TIERNAN: Continues inquiry about perceived intent should the bill

pass.

TAPE 91, B

MR. FIDANQUE: The history of immigration and enforcement in Oregon has 035 been that Hispanics in particular have been targeted. The Drug Interdiction Program is an example.

CHAIR TIERNAN: Recounts bill passed out of the Judiciary Committee that 049

basically required any person, who is behind in child support more than \$2,500 or specific amount of weeks, will lose their driver's license unless

they become current. Testimony was that 95 percent of those individuals were male; however, the committee went after the general policy that people

should pay their child support rather than pursuing males. It disproportionately fell upon white males. If this Committee adopts this policy about issuing driver's licenses to illegal aliens, it would be to establish a general policy.

074 REP. JOHNSTON: Offers that the question should really be "Are they going to drive?" If the answer is "Yes, they are going to drive", then the

second question should be "Should we entitle them or give them the opportunity to get a driver's license". If the answer to the first question is "yes" and the answer to the second question is "yes", then application of this law would be racists. ". . . if we don't take that into consideration when we make our determinations, we are overlooking something of significant social consequence."

CHAIR TIERNAN: Opines that Rep. Johnston is wrong and takes exception to the comment. Discusses the social policy question regarding laws regarding

drugs and felons carrying guns. Laws should be set based upon general policy and the proviso of appropriate enforcement.

REP. JOHNSTON: Continues to debate the policy disagreement issue.

092 REP. ROBERTS: Also takes exception to Rep. Johnston's comments, particularly the focus that the bill is directed at one specific ethnic group.

103 REP. GRISHAM: Also takes exception to Rep. Johnston's comments and a letter allegedly from a Lane County representative that accuses the Committee of being "racist" for being present for this discussion.

114 REP. JOHNSTON: Clarifies his remarks about the proposed legislation: "This legislation, I don't think, is racist. I said the application of it will be."

REP. ROBERTS: Acknowledges his misunderstanding of Rep. Johnston's statement.

132 CHAIR TIERNAN: Closes the public hearing on HB 3284 and opens the public hearing on HB $_2902$.

159 COUNSEL TWEEDT: Reviews and submits proposed HB 2902-3 amendments (EXHIBIT J)

165 CHAIR TIERNAN: Introductory comments about the purpose of the bill.

194 REP. KEVIN MANNIX (D - District 32). Testifies as sponsor of the bill. > Bill provides for an office of Inspector General in the Department of Human Resources.

> Explains an error in the bill that established the office in the office of the Governor. Submits proposed HB 2902-2 amendments that establishes the office in the Department of Human Resources (DHR). (EXHIBIT K). 203 > Describes the model used is from the Department of Corrections. > Refers to the Department of Human Resources, especially institutions and

field operations, and lack of an independent entity to provide oversight and respond to complaints. 235 > Genesis of the bill was due to the Grand Jury investigation of

Fairview Training Center.

294 CHAIR TIERNAN: Wouldn't independent oversight be more effective outside

an agency?

REP. MANNIX: Yes; however, the Corrections model has worked very well when

the Inspector General is appointed by the Governor, but the operation is within $\ensuremath{\mathsf{DHR}}$.

312 CHAIR TIERNAN: Discusses public perception and concerns if there is a different oversight entity.

337 REP. PATTY MILNE (R - District 38): Testifies in support of HB 2902 and

appropriately and provides safeguards to citizens. Provides the prevailing party the opportunity to seek costs and attorney fees. > Urges support, specifically adoption of the proposed HB 2902-1

amendments.

392 $\,$ CHAIR TIERNAN: Seeks assistance in developing one concise set of amendments.

412 REP. MEEK: Reads language from the HB 2902-1 amendments regarding a state toll-free telephone line and discusses a possible conflict.

429 MS. TWEEDT: Explains feedback from Legislative Counsel that since the local citizen review boards already do this type of investigation, that the

main Citizen Review Board (housed in the Judicial Department) might be the preferable location with local boards reporting to the Inspector General.

424 CHAIR TIERNAN: Announces that he will work with Rep. Milne on amendments for further consideration by the Committee.

TAPE 92, A

016 SHEILA BAKER, Fiscal Policy Analyst for the Department of Human Resources, Department of Administrative Services (DAS): Testifies on behalf of the Governor's Office in opposition to HB 2902, as written. The three reasons are: There is an existing Governor's Advocacy Office in the Department of Human Resources. Putting the office in the Governor's Office is not appropriate. The estimated fiscal impact for this for 1995-1997 is about \$1 million and those monies are not in the Governor's budget.

044 CHAIR TIERNAN: Is the ombudsman position for CSD in the Governor's office the position mentioned?

MS. BAKER: In the Governor's office there is still a citizens' representative position which acts as a channel for comments, questions about all state agencies. Within DHRthere is a separate Governor's advocacy office handling a variety of matters.

051 CHAIR TIERNAN: Continues inquiry about the Governor's advocacy office and the ombudsman position for CSD.

090 DR. WAYNE NELSON, Deputy Director, State Office of the Long Term Ombudsman: Testifies in opposition to the proposed HB 2902-3 amendments. This issue has been worked out in Rep. Luke's Committee with a resultant compromise for a grievance process whereby facilities can file a grievance against ombudsman designees. Opines that, pursuant to the Older Americans Act, this would be illegal. Reads language from the Act.

132 RICH PEPPERS, Oregon Public Employees Union: Testifies in opposition to

the proposed HB 2902-1 amendments:
