Clarno is excused for part of the meeting. 024 CHAIR TIERNAN: Opens work session on HB 2861 and HB 2862. HB 2861 and HB 2862 - WORK SESSION Witness: Rep. John Schoon (R - District 34) REP. JOHN SCHOON (R - District 34): Testifies in support of HB 2861 and 025 HB 2862. > Explains that HB 2861 authorizes the Secretary of State to conduct performance audits. It looks at the program specifically for any duplication and whether or not the program is adhering to the intent of the law as originally established. > Endorses the amendments by the subcommittee and states they improve the

bill. Refers to language on page 1 of the HB 2861-1 amendments, lines 1-6,

whereby the Secretary of State shall conduct the audits as directed by the Joint Legislative Audit Committee. The benefits are a control over what is

being audited for performance and programs as well as the cost.

> Urges favorable consideration of the bill.

> Explains that HB 2862 would help legislators understand what is in the Governor's budget better. It will help the Governor make the presentation to legislators and ultimately help legislators make the presentation to the

public (i.e., establish more credibility for budget matters). > The process

requires the separation of items into broad categories of personnel, equipment and capital expenditures plus it requires that personnel expenses, salaries, etc. be stated separately.

> States that inaccuracies have been reported about no pay increases for state employees. Explains background from the Ways and Means Subcommittee regarding an inflation figure that also included merit pay increases. > Supports the amendments by the subcommittee as an improvement to the

bill.

322 REP. ROSS: Explains the first purpose of the bill is to reduce bureaucracy and the need for bureaucracy. The second purpose is fairness.

CHAIR TIERNAN: Hearing no objection from ALL MEMBERS PRESENT, declares the

Refers to the Fiscal Analysis and explains the need to refer the bill to Ways and Means. Briefly provides summary of the cost to Oregon State

University (OSU). Introduces Roger Martin as a resource for more information.

364 CHAIR TIERNAN: Understands that OSU is already paying a tax into the system.

REP. ROSS: No. OSU is the only major university that is not paying a tax.

CHAIR TIERNAN: Are the counties to be covered under this bill?

REP. ROSS: No. Points out that the county is not a heavy user of the bus system -- the student population and faculty use the bus system heavily though.

376 CHAIR TIERNAN: Why tax the state buildings and not county buildings?

REP. ROSS: That is how it is currently done. No problem if the decision is that county buildings should be added. The intent is to be consistent with the way it is done in other communities.

CHAIR TIERNAN: Did OSU testify against the bill?

REP. ROSS: No.

400 ROGER MARTIN: Refers to the fiscal analysis document. The fiscal assessment has been overestimated by a sizable amount of money. Cites the cities of Salem, Eugene, Medford and Portland as all presently under this payroll tax. The tax is an "in lieu of payroll" started by Governor Atiyeh

about 15 years ago in recognition that in Portland and elsewhere the private sector was paying into the supported transit systems, but in major public payroll areas, the public sector employees were paying nothing. This is an appropriation from the various agencies toward that system and it does include that counties, cities and any public employee group must pay into it. Points out that the fiscal analysis included Albany, Astoria and Woodburn; however, none of those cities qualify, because there must be two things (i.e., a fixed route system and a separate tax levy for specifically bus service only, not for general government) -- Corvallis only specifically qualifies under those characteristics. Opines that the appropriate fiscal amount is a quarter of a million dollars versus that stated in the fiscal analysis. Suggests that a check with the Transit Division of the Department of Transportation would have provided the ongoing summaries of past bienniums that showed much less money.

439 CHAIR TIERNAN: Continues inquiry about the fiscal analysis.

018 REP. STROBECK: Who runs the buses now?

REP. ROSS: The Corvallis Transit Authority, but it is run by the city. There is a separate transit levy for the specific service. That part is paid by individuals as part of their property tax and it is also assessed to business property.

030 REP. STROBECK: Is the testimony, that cities and counties are included,

## different from your understanding?

REP. ROSS: No objection to including cities and counties; however, reads the bill to say "assess state agencies." Wouldn't think that counties would bear the tax.

REP. STROBECK: Opines that the application should include cities and counties. Disagrees with the notion that, because Corvallis has a lot of students, is why the university should be assessed. Why aren't they putting a transit district together if there is a growing need that is appropriate?

REP. ROSS: The purpose was to avoid the ongoing cost of forming a district

and other entities have experienced coordination difficulties with their districts.

045 REP. HAYDEN: Explains his understanding of the bill and that it would apply to Albany, Astoria and Woodburn.

REP. ROSS: Actually it would not. The bill can only apply to those areas that have a fixed route and have assessed a special fee for that purpose --

Albany and Woodburn haven't done that.

REP. HAYDEN: Continues inquiry about language in the bill.

055 REP. JOHNSTON: Explains that Salem does not have a payroll tax, but Salem does have a district that is supported through a property tax levy and a payment in lieu of tax from the state. Eugene and Portland do have payroll taxes to support their transit district.

067 MOTION: REP. ROSS moves HB 3224 to the Floor with a DO PASS recommendation and subsequent referral to the Committee on Ways and Means.

REP. HAYDEN: Would Salem be excluded from this bill, because Salem does not have a payroll tax?

CHAIR TIERNAN: Opines there would be difficulty charging the state twice.

REP. JOHNSTON: Explains that the money is a fixed payment that was first done last session and will require annual renewal. If the bill is passed, Salem would be able to seek the same assessment, because Salem is the only other city that qualifies.

091 MR. MARTIN: Salem's transit system is a transit district; however, it is

not funded locally by a payroll tax -- it is funded by a property tax and already receives a sizable contribution. This proposed legislation would not affect cities and counties. It would affect state agencies only and they would pay an in lieu of payroll tax payment if located in the Corvallis system itself.

REP. HAYDEN: Suggests saying that the bill applies to a city of 60,000, located in Benton County within five miles of the Willamette River.

109 REP. JOHNSTON: If this bill is sent to Ways and Means and ultimately is

passed, Salem will no longer need to come to the legislature every two vears.

REP. ROSS: Understands that Salem would need to re-assume control of their

transit system in order to access monies through the proposed legislation.

123 REP. JOHNSTON: Continues to debate the issue of who qualifies.

REP. LEHMAN: Views the bill as expanding to include cities and counties without a transit district in order to access this funding mechanism.

According to DAS, the average employee spends much less sick time now than is allocated to them. This is a paid time-off proposal similar to policies implemented in Oregon's very largest companies.

COUNSEL MOORE: Paid time off, as presented in this bill, does not affect at all the number of holidays -- it is strictly vacation, sick and personal leave.

CHAIR TIERNAN: Supplements the summary given. The bill keeps up with 150 changing times and allows professors to interchange with other universities. Once professors withdraw their money and opt to put it into this program, they can have both the PERS program as well as the new retirement program. There is no liability for the state. This program is sought by universities to allow flexibility to retain/recruit for highly gualified professors. Introduces Fred McDonnal.

166 FRED MCDONNAL, Oregon Public Employes Retirement System (PERS): > Introductory comment that by itself, members of the faculties and administrative staff from the universities of higher education moving out of the system by itself, does not present a big concern to PERS. However, points out that it is of concern if the numbers of people moving in/out of PERS become significant. It could have an impact upon employer rates and the time period that it takes the system to payoff any unfunded liabilities. PERS currently has no significant problems liabilitywise. There is a slight underfunding now, but rates include the recovery of that liability.

> A new tiered system could cause more concern, because a new tiered system

is dependent upon new, younger members coming into that tier in order to achieve savings over a period of time. If there is a migration away from the system of employers, then younger members certainly will be a part of that migration. Therefore, that could impact the results of the objective of a second tier.

> PERS does not have a problem with the bill, as written, unless the program becomes larger over time.

CHAIR TIERNAN: Acknowledges that the focus of the program is narrow. 191 Most people who have any time in PERS unlikely will go to this program. The attraction will be to new professors (i.e., new people in the system).

MR. MCDONNAL: Or, young members who want the portability feature.

Discusses the amendments requested by the Parks and Recreation Division to remove "public property" from the language in the bill, as the intent was not toward public property. Additionally, the word "knowingly" was added in the event someone was on a large piece of private property without the knowledge of the property owner. The legislation is very narrowly used in the city and it has the effect of helping to stop underage drinking.

004 GREG MOORE, Committee Counsel: Reviews the Preliminary Staff Measure Summary on HB 3392 and the proposed HB 3392 -4 amendments. The Preliminary

Staff Measure Summary, proposed HB 3392-4 amendments and the Fiscal Impact Assessment are hereby made a part of these Minutes (EXHIBIT J).

027 REP. HAYDEN: Would the long distance carriers have the ability to opt out of the dial around service?

COUNSEL MOORE: Understands that payphone operators are not regulated currently; therefore, PUC would not have authority to regulate what the payphone operator was doing.

REP. HAYDEN: Would the person billed have the chance to opt out of this system?

COUNSEL MOORE: There is nothing in this bill that would allow them to do that. The bill allows the payphone operator to charge for that call where there is no fee collected; therefore, it will be a 25 cents call regardless

of the duration of the call. The long distance carrier would have the \$4.00 or whatever charge which is dependent upon the default long distance carrier.

068 JOE GILLIAM, Northwest Payphone Association: Clarifies the issue. "We own payphones and we are not in the phone service business. Paul's group is in the phone service business, but doesn't own payphones. The dial around services, such as 1-800-COLLECT or 10-ATT . . . promote the use of using a payphone to access the services their company provides -- it's a long distance service." The payphone operators don't oppose the dial around service; however, there is a requirement by law to provide access to

dial around services. When the dial around services occur, the payphone operators are not reimbursed by the long distance carrier.

095 PAUL ROMAIN, represents MCI Telecommunications: Explains the difference

between a billing card and a dial around card plus the billing charges for calls placed.

131 REP. JOHNSTON: Explains his subcommittee vote to move the bill to Full Committee.

REP. HAYDEN: Recaps his understanding that the phones are already being paid a lump sum of \$6 per month regardless of whether or not there are any calls. Now a surcharge is being added.

MR. GILLIAM: Explains the \$6 charge.

167 REP. LEHMAN: States his understanding of the bill.

178 REP. STROBECK: Discusses payment is simply for the use of making a single telephone call.

191 REP. ROSS: Why is the legislature rushing to regulate 25-cents calls when such activity was regulated by PUC?

CHAIR TIERNAN: Explains his intent to vote affirmatively.

302 REP. WYLIE: Explains the difficulty in comparing compensation to market in the private sector. Does this bill include everything, calling it compensation and then comparing it to just salaries?

COUNSEL MOORE: Doesn't believe the bill goes that far. It does not say anything about comparison. The discussion is in terms of what it will cost

the state for this employee.

331 REP. JOHNSTON: Speaks in support of Rep. Wylie's position and that the bill "puts us on the wrong side of the equation."

343 CHAIR TIERNAN: Discusses the existing law and that the intent of the bill is to clarify.

388 MARI ANNE GEST, Oregon Public Employees Union (OPEU): FOR THE RECORD: OPEU opposes the bill. Believes the information used for the purpose of comparison is reported as a total figure when most people consider compensation as direct salary. That is not what will be reported. Opines the information used inflates the state employees' wages.

442 MS. GEST: Continues to discuss the basis used for comparison.

472  $\,$  CHAIR TIERNAN: States the design of this bill is to clarify total compensation.

TAPE 101, A

021 RICH PEPPERS, Oregon Public Employees Union: Clarifies that in all bargaining situations as well as fact-finding and other comparisons that take place currently, the benefit levels for state employees are considered

in comparison. Explains the problems in listing in the compensation plan all items in one total amount.

047 MS. GEST: Opines the bill inflates salaries and in reality makes it look as though state employees are paid higher as well as the data will be used in unfair comparisons.

059 MR. PEPPERS: Explains that the information published as salary amounts and the payroll normally attributed to fringe benefits in the previous reports cited all included those amounts in their comparisons with the market.

066 REP. HAYDEN: Cites the list supplied by the proponent of this bill and that it is not particularly comprehensive in that it does not include retirement pay, step increases, merit pay, or upgrades. Opines that exclusively the discussion would not be to discuss state and private total benefit packages, but the Budget Committee members have to know total budget packages to fairly assess the number of state dollars to allocate toward employees, benefits and other needs of the state.
