MANN: Staff submits staff measure summary and fiscal impact. (EXHIBIT A)

005 REP. MANNIX: Submits LC amendments and reviews issues of the bill with committee. (EXHIBIT B)

HB 2313 PUBLIC HEARING

MANN: Staff submits preliminary staff measure summary. (EXHIBIT C)

040 $\,$ MANNIX: Introduces HB 2313 and presents video taped testimony of Dr. Harrington.

DR. HARRINGTON, CHILD ADOLESCENT PSYCHOLOGIST, SALEM: Testifies on the psychological aspects of this bill and the sterilization process.
 -Procedure that has a high incidence of long term effects.
 -Reviews the stages that children and teen teenagers go through in establishing their identities.

-Adolescence make decisions differently than they will as they grow older and final consequences are understood.
-Sterilization is a medical procedure that has long term consequences.

280 LUKE: Questions why the age of 15 was originally chosen.

330 LEHMAN: Questions the consequences of making this type of decision at such an age.
375 -Ability to control one's random acts of violence and sexuality, and the

445 SNODGRASS: Is there an exception in the statute that deals with medical

emergencies if a young person should need to undergo a sterilization surgery.

471 BOB JOONDEPH, EXECUTIVE DIRECTOR, OREGON ADVOCACY CENTER: Submits and reviews testimony in opposition of HB 2313. (EXHIBIT D)

TAPE 21, SIDE A

 O40 -Explains the role of the Oregon Advocacy Center. -Advocate against automatic sterilization on behalf of individuals with disabilities.
 103 -Opposes the bill because it changes the current policy on informed consent an assumes that some people of this age group cannot give informed consent.

130 ROSS: Questions if the affect of this legislation would change the ability of a youngster to have final decision making if the parents and child disagree over sterilization.

155 LUKE: Questions parental notification if a15 year old goes to the doctor and willingly signs a consent for sterilization, does the doctor have to inform the parents.

175 SHIELDS: Questions if the doctor determines the patient cannot understand, they doctor does not have to take any action.

200 JOONDEPH: Under the proposed law, they only situation a person could be

sterilized is if there is a medical emergency without parental consent in
which sterilization is an outcome of the surgery, and not the primary
surgery.
240 --under current law, people under 18 can make the decision regardless or
parental permission, under the proposed law that would be not allowed.

260 DAN McCULLOCH, SEVENTH DAY ADVENTIST CHURCH, SALEM: Spoke in favor of HB 2313 and supported the information that was presented by Dr. Harrington.

and reviews testimony in opposition of HB 2313. (EXHIBIT E)
350 -Reviews history of HB 2766, the statute this bill will amend.
400 -Stump V. Sparkman, involuntary sterilization case referred to.
449 -appropriate for the state to be involved in the very intimate personal
procedures that should be made by a physician and the patient, free of
government intrusion.

460 ROSS: In your understanding of this proposed legislation, does this stop all voluntary sterilization's for 15-18 year old, unless it is a medical emergency.

468 WIMMER: That is my understanding.

that holds parents responsible, and the conflicting legislation regarding sterilization, since it currently does not require parental consent.

085 BOB CONTANGNA, GENERAL COUNSEL AND EXECUTIVE DIRECTOR, OREGON CATHOLIC CONFERENCE: Submits and review testimony in support of HB 2313. (EXHIBIT F) 120 -Issue of age of consent as set forth in the draft language reviewed,

support the change to age 18. 154 -Suggest that Page 1, line 31 the word "orally" be deleted, and the words "in writing" be inserted. 198 MANN: Reviews information provided by the Oregon Advocacy Center that documented the number of sterilization's that were required to be reported under ORS 436.255 and that six were reported, and three other informally reported. HB 2298 PUBLIC HEARING 230 CHAIR LUKE: Re-opened pubic hearing on HB 2298 for additional testimony. KENDALL BARNES, ASSISTANT ATTORNEY GENERAL: Provides information to the 235 committee on cases he has handled for the state related to HB 2298, and the mailing of obscene or offensive material via the mail by people institutionalized. (EXHIBIT G) 295 -Reports of different cases through medical intervention, patients mail privileges were withheld and the decision was supported by the District Court. 323 Four categories are constitutional protected and allows patients to have contact with attorney, advocacy groups, public officials, and the media. 380 Court of Appeals has ruled that mail privileges cannot be withheld regardless of the medical therapeutic care plan.
