-in response to Meek, discusses those enrolled part-time in private and home schooled other part; not addressing percentages in this

-in response to Meek, discusses required testing for home schoolers
090 -in response to Meek, could address your concern through administrative rules

-ESDs don't know how to treat situations, this is a clarification

117 GREG McMURDO, DEPARTMENT OF EDUCATION: Doesn't understand what the amendments do

-explains how home schooling works (register, testing requirements, part-time still require testing)

-not aware of any problems for exemptions for testing from home schoolers -testing gives credibility to Oregon's home schooling law

-doesn't understand need for this bill

-in response to Meek, discusses exemptions for private schools

-discusses three types of private schools (accredited, registered, and non-registered) for which there are no state testing requirements

-in response to Meek, state law requires privates schools to offer equivalent hours that public schools offer

180 -in response to Meek, there are no credits transferred by home schooled students; they are assessed and placed

-in response to Luke, discusses testing in classes for part-time public and

part-time home schoolers -in response to Thompson, this bill wouldn't affect your constituent who refers to home schooled children being treated differently than public schooled children -testing

-

237 TUURI: Talks about reason for amendment
