-should not be denied freedom of choice to access of health care 080 DUNCAN SOLE M.D.: Testifies in favor of HB 3340 -have helped many chronically ill patients -homeopathic treatment -constant fear that I can be discriminated against by the BME MYNA BOWERS: Testifies in favor of HB 3340 110 -personal experience with Lupus disease -then tried alternative medicine which included vitamin and diet changes -angry that choice has been taken away from me 139 JOE SILL: Testifies in favor of HB 3340 -choice -power issues -personal experience -treatment of symptoms -alternative doctor was able to improve my life by looking at food allergies -this doctor is prescribing same medicine as my previous doctor but because of his background in prescribing "alternative" medicine the insurance company sends me statements that this is being reviewed 210 DR. - I have joint swelling and itching; was given eleven types of medicines
