021 CHAIR PARKS: In my judgment if you defeat the bill it dies for the session. This is an up or down vote on this bill.

031 REP. GRISHAM: I would like to object to the process that forces us to make a vote in full committee.

035 CHAIR PARKS: It isn't any different than all the other bills, the bills that come from the crime and corrections committee are up and down votes.

042 REP. CARPENTER: This is not the approach we should be taking. I think SB 447 is a bad piece of legislation.

053 REP. JOHNSTON: As a general rule, there might be some validity to your comment, but in this particular case I think there is none.

063 CHAIR PARKS: Republican or democrat, we do not get into that in this committee.
