257 HOLLY ROBINSON, COMMITTEE COUNSEL: The reason for creating the commission was to be an independent body, explains criteria. One of the complaints was that the council grew to 24 members which was too many. There are seven members in this commission and the rest of the work will be

done by a subcommittee.

REP. NAITO: What is the fiscal impact on this? Does it need a referral 277

to Wavs and Means?

280 REP. TARNO: For the most part, it is unimpacted, explains.

284 REP. TIERNAN: Compliments the subcommittee for their effectiveness and work on this bill.
