219 REP. BAUM: I hope you understand we're having a public hearing today.

223 KEISLING: Yes, I appreciate it and it is to your credit that there is an opportunity for people to do this.

228 REP. BAUM: We want to give it some discussion because we feel when you deal with political speech, you have to be very careful because it is the foundation of the first amendment.

236 KEISLING: I think that may be right but I would ask who was responsible for that discussion not occurring? The opportunity to oppose this measure and to raise those issues, was there to be taken six months ago.

247 TIM RAPHAEL, OREGON STATE PUBLIC RESEARCH GROUP (OSPIRG): Testimony in opposition to SB 178. [EXHIBIT N]

438 REP. MILNE: My mother-in-law sends \$25 every year to her favorite organization, which happens to have a "pac", in your statistic's you've given us here, would you have counted her as an individual or as an individual as part of a "pac"?

444 RAPHAEL: No, thirteen cents of the individual is direct individual contributions to candidates.

449 REP. MILNE: So you don't count individual's as being part of "pac" contributions?

452 RAPHAEL: No, we counted that as a "pac" contribution.

455 REP. MILNE: But you do recognize that individuals are involved in "pac"?

459 RAPHAEL: Certainly.

TAPE 73, SIDE B

015 REP. BAUM: My concern is that the numbers quoted really are the power of the incumbency.

Most of my people don't move around, they have been there forever. I'm afraid that if we don't do something we're going to have the wealthy able to afford to run and we're going to have the middle class, the folks who work 8 to 5 that can't go out on the spur of the moment and solicit contributions.

033 RAPHAEL: This isn't about paid advertisements. In terms of the wealthy candidate provision, the amendments in SB 178 strip out our trigger mechanism that have a heavy disincentive to candidates financing their own campaigns.

046 REP. BAUM: My concern is again, that two or three hundred thousand dollars of real money, and your in the hunt.

049 RAPHAEL: You are today as well.

051 REP. BAUM: Right, but then it's hard for the challenger to compete with that.

053 KEISLING: The point you raise is exactly what I think in the end is the strongest argument for Ballot Measure 9. Forty eight incumbents out of fifty two, were re-elected under the old rules. I want candidates who in

the end are going to build their campaigns on door to door efforts.

079 REP. BAUM: You've been a candidate before and that can't be true.

080 KEISLING: With all do respect Mr. Chair, there is a bill in this committee that would undercut that very principal, it's a tax credit that is given to incourage Oregonian's to give to small donation candidates.

086 REP. BAUM: You don't intend to move that one, do you?

088 KEISLING: I think that is wise, because it speaks exactly to your point. The problem is a generic problem. The problem to raise that much money is a far bigger deterrant for people to get into this process.

093 REP. BAUM: I think we need to go to professional politians and you'll be right.

095 KEISLING: I disagree, I don't think we should.

097 REP. BAUM: To do that kind of solictiation takes so much time out of a person's life that they can't have a decent job and have a respectable family life.

097 REP. LUNDQUIST: You say that you can run an effective campaign with this \$100 limit's, have you run campaigns?

100 RAPHAEL: I ran the ballot measure 9 campaign.

102 REP. LUNDQUIST: The best system is one that informs the people, that is the bottom line. It is costly to run a campaign. How are we going to inform the people? If we don't want to have informed voter's, then I say keep the campaign limits as low as you want to.

124 KEISLING: I have not ony run a legislative campaogn but I have run a state wide campaign, I raised the equivalent of about twenty five cents per voter. The silence was resounding on this issue. We should see how this system works out and then possibly change it in the '97 session.

149 REP. WATT: Why was the silence resounding?

151 REP. KEISLING: I don't know, I think people were afraid they would lose. I assume people thought it was a futal effort.

179 REP. BAUM: I am also concerned about Measure 11, because for any one to understand

Measure 9 or 11, would have to have a volume of the ORS sitting beside them because of the statutory references. I reject the notion that the public understood the fine details.
