089 BRAD WITT, Secretary-Treasurer of Oregon AFL-CIO & MARLIN AERNI, State Association of the United Paperworkers International Union: Testifies in favor of HJM2, 3 & 4.

146 REP. NAITO: Questions why the change would make any difference.

149 BRAD WITT: Responds that: -"best available science" has not proven not to work. - gives example - will insure accuracy.

167 REP. JOSI: Refers to Regional Power Council's Recovery plan. Is concerned that verifying may cause delays in need actions.

200 Discussion with BRAD WITT continues.

238 MARLIN AERNI: United paper workers have seen losses of jobs due to the endangered species. Supports Brad Witt's testimony and HJM2.

251 REP. CORCORAN: Asks what is the basis for support.

259 BRAD WITT: Relates that past actions based on "best available science" have proven erroneous. Answers REP. UHERBELAU'S question on meaning of "verifiable science" that the scientific community is able to replicate studies.

278 REP. THOMPSON: Voices concern over consequences of the change. BRAD WITT responds that it would lead to making certain actions taken are "prudent and justified on behalf of the species".

310 MARLIN AERNI: Cites the spotted owl situation as an example.

336 GIL RIDDELL, Association of Oregon Counties and Council of Forest Trust Land Counties: Testifies in support of HJM2, 3, 4. (EXHIBIT B). Briefly describes the two organizations he represents.

107 REP. THOMPSON: Talks of the pinniped species growing in numbers and potential danger to salmon.

138 FRENKEL: Answers REP. LUKE's inquiry on Sierra Club membership.

160 REP. LIZ VAN LEWEUEEN, House District 37: Former Chair of the House Natural Resources Ag Forestry subcommittee during last session and interim.

Responds to earlier comments on the Botkin study and testifies in favor of

HJM2, HJM3, and HJM4.

205 REP. FISHER: Comments on Botkin report.

 $252\,$ REP. THOMPSON: Expresses concern over the word "lethal". REP. VAN LEWEUEEN comments.

280 JIM MYRON, OREGON TROUT: Testifies against HJM2, HJM3, and HJM4.

301 REP. JOSI: "You're saying if we use the words "sound, verifiable science" we couldn't enact SJM4?"

305 MYRON: "Distinct possibility."

310 REP. CORCORAN: Initiates discussion on whether economic concerns are addressed by the President's Timber Recovery Act. MYRON answers that they are considered.

320 MYRON: Responds to REP. NAITO's inquiries on Oregon Trout membership.

338 REP. NORRIS: Does process for enlisting endangered species use economic

effect as criteria. MYRON states it is based on science and biology.

360 PAUL HANNEMAN, Pacific Fisheries Legislative Task Force, Cloverdale, Oregon, : Testifies in favor of HJM4 (EXHIBIT D). Refers to Resolution 93-1 which calls for control of California Sea Lion and the Harbor Seal.

018 REP. THOMPSON: Asks if these marine mammals are harming the fish and if

fish populations could be restored. PAUL HANNEMAN states "we'll never have

a return of some of the more sensitive species to some of the Oregon Coast Rivers...."

015 REP. NAITO Inquires if amendments from last year have been implemented. HANNEMAN discusses his why they haven't.

042 REP. NAITO: Should term be more specific than pinnipeds?

047 HANNEMAN: Current terminology is appropriate.

065 REP. THOMPSON: Would establishing a "stock-size" or quota on the marine

mammals seem to be proper terminology to accomplish--if there are only ten seals?

077 HANNEMAN: Further discussion of population growth of seals and sea lions. Personal experiences including day by day photography of animal populations. Increasing by 10 percent plus each year. 118 -in response to REP. NAITO's inquiry of alternate ways of removal, states if removed sea lions and harbor seals will swim back.

126 Closes PUBLIC HEARING on HJM2, HJM3, and HJM4 .

Opens WORK SESSION on HJM2.

133 MOTION: REP. NORRIS: Moves HJM2 be sent to the Floor with a DO PASS recommendation.

145 CHAIR TARNO: Hearing three objections, calls for roll.

168 VOTE: In a roll call vote, REPS. CORCORAN, FISHER, LEWIS, LUKE, NORRIS, WELLS, WELSH and TARNO vote AYE. REPS. JOSI, NAITO, THOMPSON and UHERBELAU vote NAY.

173 REP. NORRIS: Amendments needed to broaden the focus of the bill with respect to the Salmon and the water issues.

203 REP. UHERBELAU: Points out there can be a fiscal impact of listing an endangered species and not listing it.

206 REP. CORCORAN: Responds to REP NORRIS comments. - Line 6, agree with including salmon issue.

235 CHAIR TARNO: Reads lines 17-22, item 1 and item 2. Comments by REP. NORRIS.

246 REP. FISHER: Bill addresses primarily forest products. REP. THOMPSON suggests more work on it. REP. NORRIS comments on effects of Endangered Species Act.

282 REP. JOSI: Initiates further discussion of salmon issue. REP. NAITO raises terminology questions again.

343 REP. CORCORAN: Wants forestry intent kept in bill.

369 REP. WELSH: Agrees. Bill may become "water downed".
