313 REP. CORCORAN: Questions if there is a commitment on the part of Kinross to train and employ dislocated timber workers.

BENNETT: Absolutely, quotes policy statement. "We expect to hire 65 of our work force from the local area."

320 REP. CORCORAN: For the record, I want a commitment from Kinross regarding employment of displaced timber workers.

324 BENNETT: You have an absolute guarantee that will occur.

330 LYDIA TAYLOR, INTERIM DIRECTOR, DEPARTMENT OF ENVIRONMENTAL QUALITY: Provides comments regarding amendments. Not appropriate to single out one company.

386 -Responds to REP. NAITO regarding potential damage from the mine. Don't have staff to monitor potential cumulative effect. Always some risk of damage.

417 REP. CORCORAN: Asks her about the amendments.

425 TAYLOR: Responds a ceiling of \$100,000 per year would allow for contracting of instream monitoring and inspection. (Allows for increases in costs over time.)

437 REP. CORCORAN: Asks about adding "inspection" to line 27; questions spillage wording.

460 TAYLOR: Suggests additional language, "DEQ may require an offsite spill prevention plan of the company and their permit".

035 REP. TARNO: If fees are increased, how would you spend them.

039 TAYLOR: Contract with a firm to do regular inspections.

046 REP. CORCORAN: DEQ would just need the authority to spend the additional revenue.

051 REP. UHERBELAU: Questions if HB 3427, as amended, would conform with the federal clean water act.

054 TAYLOR: If permit issued it would have to comply with the clean water act.

056 REP. UHERBELAU: Agreeing to assume liability may not get you there. Asks about requiring them to carry a policy of a certain amount to assure funds if there is a spill.

068 TAYLOR: Not expert enough in bonding requirements. DEQ felt having the parent company responsible was "as great a satisfaction as one could achieve".

077 REP. CORCORAN: Proposes changes to the amendments, (Exhibit H), page one, line 2, moves to strike the words "it is likely that".

088 REP. LUKE: Comments they could be in real trouble if they tried to do that. Could be violating law.

095 REP. NAITO: Agrees with the intent, but could be setting up violation of affirmative action.

101 REP. CORCORAN: Happy to withdraw that, but it's currently being done in a pilot program in Sweet Home. Withdraws his motion.

107 REP. LUKE: Afraid it would leave the bill open to legal challenge.

109 REP. CORCORAN: Continues with amendment motion - page 2, line 27, after "monitoring" add "and inspection".
Line 29, replace the word \$50,000 with \$100,000.
Page 3, after line 19, create a (4), Insert "DEQ may require an off-site spillage prevention program."

120 REP. NORRIS: Asks about subsection 6 (a) in conjunction with the proposed (4). Thinks there's a wording problem.

REP. NAITO: Suggests rephrasing, "a spillage prevention program, if required by DEQ."

140 REP. NORRIS: Questions wording.

145 REP. LEWIS: Could say "the applicant agrees to create an off-site spillage prevention program if required by DEQ."

152 CHAIR TARNO: Suggests LC would out the verbage.

159 REP. CORCORAN: Moves the conceptual amendments, as previously stated, to the HB 3427-2 amendments, BE ADOPTED.

CHAIR TARNO: Hearing no objections, the conceptual amendments to the HB 3427-2 amendments are ADOPTED.

250 REP. CORCORAN: Had two bottom lines in this discussion. Timberworkers, and degradation of the water. Does believe that there are adequate protections both federally and the monitoring systems oversite that DEQ will be doing. Will support the bill.

264 REP. LUKE: Asks about the meeting in Mill City: was unable to attend. Doesn't believe there has been sufficient testimony for him to vote yes.

3103-1 amendments. Urges support of the bill.

381 REP. WELLS: Asks about section one.

385 SCHELLENBERG: Some land when you irrigate it becomes Prime & Unique,
the language covers both types.

405 REP. NAITO: Would want this to be limited to productive farm land.
Would they be able to specify legislative intent that this be productive
farm land?

420 SCHELLENBERG: Suggests that's a good idea, and they would agree with
that.

consider circumstances regardless of the owners request.

124 SCHELLENBERG: Original bill had clearer intent.

130 REP. NORRIS: Why would the owner want the designation of high valaue
farm land if it did not otherwise qualify.

134 SCHELLENBERG: May qualify for additional water where another property
may not.

145 BLAIR BATSON: Worked closely with Jefferson County, have class III & IV
which are growing the same as crops as High Value land. Limiting parameter
should be whether the soils are capable of producing at the same level as
the high value farm land.

184 REP. LUKE: Has a problem with the way the bill is written. The wording
needs some work.

320 DILORENZO: The bill protects farmers from litigation by new people who move into their area.

330 TERRY WITT: Bill is to help farmer harvest their crops in the most economic way.

364 REP. NAITO: Has problems with some of the language dealing with pesticides.

400 CHAIR TARNO: Doesn't the applicator have to be licensed.

405 DILORENZO: Drift of pesticides is trespass is it not?

411 DILORENZO: Would submit that the farmer is not using the pesticide consistent with the label.

030 REP. LUKE: Local ordinances could ban some farm practices.

035 REP. CORCORAN: Asks if there were court cases that went against farmer, and is that what generated this bill.

042 DILORENZO: Not a particular court case. Last session Oregonians for Food and Shelter tried to broaden. Hope this legislation will allow the farmer to have a certain comfort level over their farm practices.

064 REP. CORCORAN: Has the Farm Bureau been brought into this.

071 REP. FISHER: They are having problems right now. Have a grass seed operator there who has to run it all day and all night at certain times. Are being threatened with litigation, and are harassed constantly.

092 CHAIR TARNO: Closes the PUBLIC HEARING on HB 3457.

Opens the WORK SESSION on HB 3457

MOTION: REP. JOSI: Moves HB 3457 to the Floor with a DO PASS recommendation.

101 REP. NAITO: Will vote no, but wants more time to study the issue as there are sections of the bill she likes.

VOTE: In a roll call vote, the motion CARRIES with a majority vote of 11 AYE, 1 NO (REP. NAITO).

REP. FISHER will lead the discussion the Floor.
