003 CHAIR STARR: Calls meeting to order at 5:45 p.m.

005 TOM MANN, COMMITTEE ADMINISTRATOR: Explains the bill to committee and
HB 2931- B14 amendments dated 6/5/95. (EXHIBIT A)

032 SEN. SHANNON: Asked for clarification on the deletion of line 10
through 14.

040 REP. STARR: COSA- Confederation of Oregon School Administrators will
probably oppose these amendments.

049 MOTION: SEN. TROW: Moves to adopt HB 2931-B14 amendments dated 6/5/95.

069 SEN. SHANNON: Comments on superintendents pay raises in the state.

082 VOTE: In a voice vote, all members present vote AYE.

095 OZZIE ROSE, COSA: Comments on the bill and was supportive of bill if it
addressed the minimum pay scale. Concern that the bill as amended is taking
on pay issues, which should be taken handled on the local level, not on the
legislative level.

140 CHAIR STARR: Recesses the full meeting for a call of the House.
160 -Senator Trow and Senator Shannon continued discussion with Ozzie Rose,
trying to development further amendments.
170 ROSE: Recommends deletion of line 27, subsection 4.
192 -Trying to adjust the base 80 to 85% over a two year period phase in.

200 SEN. TROW: COSA is not going to support this bill. Would like to go
with the amendments.

212 REP. STARR: Reconvenes full committee meeting at 6:03 p.m.

230 MOTION: SEN. TROW: Moves HB 2931-14 amendments dated 6/5/95 and the
further amendments and that the bill be re-passed.

VOTE: In a voice vote, hearing no objections, the motion CARRIES.
