TAPE 1, A

- 003 CHAIR JONES opens the WORK SESSION on HB 3239 at 11:48 A.M.
 - The issue is a set of amendments (HB 3239-A5) that have been passed out.

These were agreed to by myself and the Governor. It was his request that the appointing authority that was in the original bill be changed from the Speaker of the House and the President of the Senate and the Land Board to the Governor.

- 006 MOTION: SEN. JOHNSON: Moves the HB 3239-A5 amendments.
- OO8 CHAIR JONES: Are there any objections or further comments?
- 010 SEN. DWYER: Would like to know where the public is in this representation. Seems like they've been left out of this.
- 012 CHAIR JONES: The people that we're suggested in the original bill has not been changed.
- O14 SEN. DWYER: I understand, but we're changing the way we're appointing them. Why isn't there a public member on here.
- 016 -I don't see anybody representing the public. I see scientists, ranchers, government officials, beneficiaries of the Common School Fund
- 020 SEN. JOHNSON: First, the Governor has the public interest in mind more

than any of these other individuals, secondly, the representative of the Division of State Lands the general interests of the state.

- 024 SEN. DWYER: Do you have a problem with putting a public member on there?
- 025 CHAIR JONES: Makes reference to line 34, "A representative of the Common School Fund", that is the public.
- 028 SEN. DWYER: Well tell me who they are.
- 029 CHAIR JONES: You'll have to ask the Governor that.
- 030 SEN. KINTIGH: That could be anybody that has children in school.
- O34 SEN. DWYER: Would say that this beneficiary of the Common School Fund is not the public. Are you trying to tell me this is the public member? Is that what you're trying to sell me on?
- 038 CHAIR JONES: I'm not trying to sell you on anything.
- O43 SEN. DWYER: Let's go with it. I think we're leaving the public out but I don't have any strong feelings about it. But I think we're here to represent the public and we ought to be cognizant that some independent person who has no interests is the kind of person that I want on this.
- O49 CHAIR JONES: Any further comments? Hearing no objections, the motion CARRIES. The HB 3239-A5 amendments are adopted.
- 054 MOTION: SEN. DWYER: Moves the adoption of the CONFERENCE COMMITTEE REPORT to recommend that the House concur in the Senate amendments dated May 26, 1995, and that the bill be amended with the -A5 amendments and be RE-PASSED.
- 057 VOTE: In a roll call vote, all members present vote AYE.
 - SEN. JOHNSON and REP. JONES will carry the bill to their respective floors.
- 070 ADJOURNS the meeting at 11:54 A.M.
