> Explains the original bill was amended in the House to exclude the school district superintendent from requesting to have a student's driver's license revoked if they did not behave at school.

- $\,$ 040 $\,$ JIM GREEN, OSB A: Refers to Sec. 5 in HB 2487A language makes it a local decision left to the school board.
 - > Goes into more detail about why that language was included in the bill.
 - > Due process language in Sec. 5 (1)(e).

070 REP. PETER COURTNEY, District 33: Talks about work group that was put together during

 $\,$ the interim and crafted the legislation. Only point of contention is the driver's license.

> Reviews background on the issue and feels taking away license is just) fied.

SEN. BAKER: Isn't this vindictive?

REP. COURTNEY: Sending statement to general population of students not to be associated with bringing weapons to school. This is a policy statement and incentive. Allows school boards discretion.

SEN. BAKER: Struggle with an additional punitive action for an expelled student.

 $\,$ REP. COURTNEY: Talks about serious safety situations in schools. Bill is well-thought out

public policy.

175 REP. DENNIS LUKE, District 54: Agrees with automatic suspension for bringing weapons in school. Objects to taking driver's license away for something not directly related to driving.

 $\,>\,$ Refers to the HB 2487-1 amendment (EXH. B) which takes out the driver's license language.

 $\,$ SEN. TROW: Sees it as having a deterrent effect. If students know before hand they will lose

their driver's license for that kind of behavior, it will deter them.

REP. LUKE: They are going to be driving anyway.

259 SEN. BAKER: Chaired Task Force on Juvenile Law during interim. Kids said they take guns to school because they don't feel safe. Taking away driver's license is not a deterrent to that behavior. Still have guns in schools.

 $\,$ SEN. SHANNON: Is there any law that forbids schools from doing this now? Does federal law

say we have to do this?

REP. LUKE: Federal law says the student must be suspended for one year. HB 2487A goes

beyond federal law and provides if student is suspended at one school, they cannot go to another school

SEN. SHANNON: What are students suppose to do for that year.

> The -A7 amendment lowers the rate of pay and would be acceptable (EXH. E).

JOSEPH BENNINGHOFF, COSA: Submits and reviews written testimony in 150 opposition to HB

2931 because of the fiscal impact and inconsistencies in compensation (EXH.

F).

245 DON SHORE, OEA: Testifies in favor of the bill because it is important to maintain pool of

substitute teachers.

> Substitute teachers are generally more experienced and not beginning

teachers.

> Not all substitute teachers are represented by the OEA.

287 VICKIE TOTTEN, OSB A: Primary concern is the fiscal impact. Hits smallest districts the

hardest. Fiscal statement did not include the five percent experience level increase.

308 BILL BECK, Portland Public Schools: Sec. 4 and 5 do represent a cost increase for

Portland. Public Schools. Does not support the bill. Bill puts the Legislature in the position of

negotiating for a group of teachers who are represented by a union in their district.

SEN. GOLD: What percentage of the fiscal impact would be on Portland Public Schools?

BECK: Do not know. Pay 86.5 percent to substitutes in Portland Public

Schools. Many beyond 20 days and become temporary teachers. Represents financial

improvement to one group of employees who are represented and organized within their district.
