of benefited communities served by Blue Mountain Translator District (Exhibit B) -states that currently with no effective way to collect delinquent fees, 50% of fees are not being paid to District -refers to Oregon Map to illustrate District area which serves approximately 146-150,000 people -without assistance in collecting delinquent fees, the District may need to cease operation within the next 1-1/2 years -questions and discussion about other entities that might be affected by 065 legislation 074 -presents concept of "friendly amendment" and states support from Department of Revenue, Union County Assessor, and County Assessors 096 Jim Manary -Oregon Department of Revenue (quorum established) Manary -explains situation prior to Measure 5 which allowed a number of entities to use the tax roll for billing and collection of fees for services -presents concepts: 1) collection service will only be for delinquent accounts, and 2) a district wanting to use the roll will pay a fee for the service 126 Chair Phillips -questions about when amendment could be available to committee and costs of administration 136 Mark Noakes -Linn County Assessor and Tax Collector, Albany -represents the Association of County Assessors and Tax Collectors -states that assessors will be meeting tomorrow, and should have a better understanding of bill within a few days -generally, tax collectors are concerned about "snowball effect" of this type of action and would like to it to be narrowly defined 161 Chair Phillips -asks parties involved to coordinate work on amendments prior to April 11 -declares possible conflict of interest because he owns property in the subject area SB 718 PUBLIC HEARING (SOME TESTIMONY ALSO REFERS TO SB 487) 185 Sen. Gold -Oregon State Senator District 7, Portland -presents measure description, referring to Revenue Impact of Proposed Legislation (Exhibit D) -measure creates a refundable earned income credit equal to 25% of the federal earned income credit 276 -points out that SB 718 affects taxpayers in Oregon with incomes under \$30,000 per year - representing the majority of Oregon taxpayers -explains rationale for the federal earned income credit and advises that "at least seven states have followed suit" -"from my perspective, state credits are good policy..for the same reason that it's been good policy at the federal level" -introduces Judy Miller of Oregon Outreach Coalition 296 316 Sen. Bill Dwyer -Oregon State Senator District 21, Springfield -presents policy and position stated in SB 487, which is similar in concept to SB 718 -"we have two approaches to welfare: if we expect people to work and not live in poverty, then government has to recognize their ability to pay what the costs are associated with living and try to make adjustments" 364 -states that earned income credit provides an incentive to work 370 -questions and discussion 375 Chair Phillips -notes for record, desire of Representatives Wooten and Brown to testify on SB 718 (see written testimony from Representative Brown as Exhibit K) 380 Judie Miller -Oregon Outreach Coalition -refers to distributed testimony in support of earned income tax credit (Exhibit F) TAPE 075 SIDE A -discussion and questions 051 Bill Resnick -Portland Jobs with Justice 065 -states strong support for refundable EITC and exempting the federal EITC

from taxes at the highest feasible level -testimony includes comment on economic trends, "official" vs. "real" unemployment, wage decline for many Oregon workers, and poverty levels -speaks about limitations of earned income tax credit Barbara Mulcahey -Adult and Family Services, Retention Specialist in 128 cooperation with the Mt. Hood Community College Steps to Success Program -presents testimony in support of SB 487 (Exhibit G) 179 - McMinnville, OR Laura Lemos -relates personal experience as head of household with five children and recipient of federal earned income tax credit -explains financial and work opportunity ramifications of going back to work rather than staying on welfare -describes emotional stigma of having to accept help from Adult and Family Services 242 Michael Carrigan -Oregon Peace Works Executive Director -comments on written testimony submitted in support of both SB 718 & SB 487 (Exhibit H) 266 -in response to question from Chair Phillips, explains the process Lemos of working with employer to arrange monthly federal earned income credit which is included in her paycheck -states that she receives \$84/month, which "means the difference between making it and not making it a lot of times" Sara Fleming -Oregon Hunger Relief Task Force 291 -summarizes testimony submitted by Rachel Bristol Little of the Oregon Food Bank in support of a state refundable earned income tax credit and also in support of exempting the federal earned income tax credit from being taxed in Oregon (Exhibit I) -distributes written testimony from Oregon Hunger Relief Task Force in support of SB 718 (Exhibit J) 355 Bob Castagna -Oregon Catholic Conference -states that Ecumenical Industries of Oregon, Lutheran Office on Public Policy, and Oregon Catholic Conference have been requesters of this legislation in former sessions -speaks in support of policy that will begin a state earned income tax credit -comments on fiscal/revenue impact and concept of elimination of state income tax obligation for those below the federal poverty level 420 -questions and discussion Castagna -"because you're involved in welfare reform this session, I 480 think this should be considered a significant piece of the puzzle" Chair Phillips -notes testimony received from AFL-CIO in support of SB 718 490 and SB 487 (Exhibit L) TAPE 074 SIDE B SB 487 PUBLIC HEARING Jeannie Berg-Rempel -Jobs with Justice, Salem 044 -speaks in support of "earned income tax credit as an important aspect of a living wage agenda that is aimed at lifting workers out of poverty" -cites example of how federal EITC moves people toward greater self-sufficiency 075 -points out effectiveness of EITC in addressing the issue of women in poverty -states position of Jobs with Justice that "the greater percentage we can have for an earned income tax credit the better" 095 Chair Phillips -suggests that a package be prepared prior to referral for Ways and Means consideration -asks staff to prepare varying percentage and credit options for fiscal and policy consideration -adjourns meeting at 2:12 pm
