by a state agency as an environmental specialist or a natural resource specialist unless they work in

the on-site sewage treatment program.

198 CHAIR BUNN: First, there must be a sign)ficant difference in what the on-site sewage staff does and what the rest of the staff does. Could you explain that difference to us, briefly?

200 TAYLOR: The on-site sewage staff people are direct service people. In Oregon, counties typically deliver on-site sewage-permitting activities. In those counties that do not wish to offer that service, DEQ is required by law to do so. It is a direct service--the staff physically visit the site. Other staff at DEQ do other things, typically, establish standards by which water or air would protect human health or the environment. They would do analysis of hazardous waste sites and determine proper cleanup and perhaps contract for the clean-up of sites where hazardous waste had been spilled, etc.

223 CHAIR BUNN: When you hire the latter, the non-on-site staff, I would assume that you set up certain criteria in terms of their employability that they meet certain standards for doing the job that's involved. Is that right?

227 TAYLOR: That's correct. We would set minimum qualifications in order to apply for the job, which would include appropriate education, typically four or more years of college or equivalent, plus experience depending upon the level at which we were hiring the person. They would have to demonstrate expertise in their field before they qualify.

233 CHAIR BUNN: A comment I want to make before I ask the next question I don't accept the position that specialists create the problems that were test)fied to. My concern is, why should we exempt DEQ or state agencies if exactly the same kinds of people exist in private industry in similar circumstances? Why don't we deal with the whole issue at one time'?

243 TAYLOR: 1 think it would be very reasonable to do so. I'm just not in a position to speak for private industry about what all of their qualifications are. 1 didn t feel it would be appropriate for me to offer an amendment on their behalf.

247 ART WILKINSON, Committee Administrator: The two amendments would be an either/or situation, right? You aren't proposing both sets of amendments?

committee. There are four people on the committee that hold pharmacy degrees. We would like to balance the committee out so that it's fair.

220 CHAIR BUNN: What's wrong with those people making the kinds of decisions that they make? Do they make unfair decisions or unsound decisions'?

224 WALKER: The pharmacy people on the Board are extremely unreasonable. They tend to argue on each item that we want. They have been very unfair.

233 CHAIR BUNN: One person's definition of fair is not necessarily another person's. This committee needs to be able to come to what we see as a reasonable balance.

237 SCOTT GALLANT: Addressing the committee re: a list of drugs that naturopathic physicians can use. Some of these may be considered dangerous---opium is one of them.

260 HANNON: What is it that's not working'? Do both sides have the same assumption that it's not working?

263 WALKER: It just doesn't work at all. The pharmacists control it with four votes. They also have a medical doctor, and there's a great deal of prejudice against the naturopathic people on this Board. We would like to have a better representation so that we can continue to work. We haven't been able to meet since 1990 because the pharmacists on the Board would vote out the whole list that we would have on there.

278 HANNON: Who makes the appointments to this formulary board? Is it the Governor?

280 WALKER: No, the medical board appoints one medical doctor, the pharmacy board appoints two pharmacists, the naturopathic board appoints two people, and then the board gets together and finds a pharmacologist and a pharmacognisist who has had pharmacy training.

288 HANNON: What can be done so that you would be willing to come to a reasonable, middle ground solution?

292 WALKER: We would have two naturopaths, a pharmacist, a medical doctor. We'd have to getone more person on there, and we think this person should have an advanced degree in pharmacy, but to make it fair, we'd say that this person could have a license from a pharmacy board, but the naturopaths would like to pick this person so that the person would have some knowledge about our practice. Medical people have no knowledge of us.

307 CHAIR BUNN: You're basically saying that we need to stack the Board with naturopathic physicians. Why have it, then? If they're the ones who are going to decide things, and they'd

decide everything they want, why have a gatekeeper, so to speak? There are some politics here on both sides that I have trouble with. Why have it if it's controlled by your group and would basically set all the policies that your group wants?

321 WALKER: It has been controlled by the pharmacy board for the past six or seven years. Thepharmacy people have had the dominant vote. We're not going to say that we want to control it; we just want to pick a person who is knowledgeable about our practice.

326 CHAIR BUNN: What's the role it's supposed to play for our state? What is it supposed to

accomplish?

328 WALKER: References a compromise reached four years ago.

335 BUNN: And in the compromise, what's supposed to occur in this process that was good public policy'!

336 WALKER: We were supposed to publish a list that this committee thought was natural products.

338 CHAIR BUNN: And at the time that compromise was reached, was it felt then that the mix on theboard was appropriate, or that's the best the various groups could get?

343 WALKER: That was the very best mixture that we could come up with because of the conflict that we had between the pharmacy board, medical board and our board. Senator Kennemer was on this committee at-that time and he helped to formulate the board.

349 GALLANT: When we agreed to the compromise in 1989, we designed the composition of the board to include various practitioners so that you would in fact have a board representation of individuals who in fact had expertise naturopathy. So far, in in pharmacy, pharmacology, practice of medicine, and fact, it has worked. In the one period of time that they have met, they in did come to an agreement on a list. The proposed legislation was in fact part a result of the Attorney General's opinion on rules that the board had adopted that some believed went well beyond the statutory ability of naturopathic physicians to use. In fact, the A.G.'s opinion said that. So this legislation was a response to that concern of both the board and the OMA, as was the composition. I don't think it s fair to say that, in speculation, over an almost five year period of concem, that new members of the formulary council might not come to full agreement with the Board of Naturopathy in what they believed ought to be added to the formulary list.

385 CHAIR BUNN: Let's assume that this legislative committee felt that there should be more restriction on substance use by naturopathic physicians than those physicians did. How do we get control of that issue, with the board controlled by naturopathic physicians?

395 WALKER: The Governor appoints the Naturopathic Board of Examiners. 1 think they'd have enough confidence that these people were going to abide by the state statute.

401 CHAIR BUNN: I have a problem with that because if the state statute

allows them to have an expanded list and they believe it should be expanded beyond what we believe, then my view is that if it's controlled by naturopathic physicians, there is no controlling factor there. I want to make it clear as I say that, that I believe in a role for naturopathic physicians as well as others in the health care area, but I also personally believe in some kind of gatekeeping role that might restrict the use of those substances more than naturopathic physicians would like.

476 CHAIR BUNN: Still addressing Dr. Walker: I'm formulating an opinion as we go through this that we don t have that adequate protection with the formulary council controlled by naturopathic Physicians. 483 LEONARD: If we left it at five members and just rearranged who those members were from what is in the bill to two physicians licensed by the BME, two naturopaths and a pharmacist, do you feel that would give you a better balance than what you have now?

496 WALKER: The medical board has stated they know nothing about the practice of naturopathic medicine. They re not going to be able to find any doctors that have any knowledge of natural products and things like that. However, the pharmacy board and the medical board has always sided against us in all of the testimony and all of the bills we've ever tried to get down here.

500 LEONARD: I thought I heard you say some time back that the medical doctor on the board supported you.

502 WALKER: Dr. Hazel supported ws, however, he's not around anymore.

504 LEONARD: But according to you, he came from a profession that is at odds with you. If you had a different mixture than what vou have here. would that interest !ou'?

I would like this committee to be able to work with both sides. I don't like the impasses that go on because two groups can't get together and work successfi~lly at something. We're going to take a break. The two of you need to visit together during the break and try to reach a compromise. If you've got anything when we come back from break, we can talk about it. If not, we'll have to bring it back later.

666 MCCOY: Could you explain again what your group wants? (Directed to Haley)

668 HALEY: If you remove the area that we're proposing to remove. the pharmacopaeia would be based on the text used in the accredited schools, rather than have the BME do it, do it with the text that s being used in the schools. That makes the most sense, rather than turning it over to medical examiners who don't have the expertise in this area.
