670 KENNEMER: Can you speak to the issue of competing interests perhaps getting into transferring care to different levels, or different competing interests?

673 CARLSON: This Council would not be charged with any responsibility in looking at transfer rules or regulations. They would have a fairly narrow focus of looking at changes to the payment system for services, and then trying to assess the impact those proposed changes would have--whether they

would have a positive or adverse impact on the quality of care and services

provided to and received by Medicaid clients in the state. I would not see any circumstance under which they would be involved in transfer rules or regulations.

685  $\,$  KENNEMER: I see in Section 2 on Page 3 (referring to -9 Amendments), that the recommendations is with regard to the reimbursement. Is it limited

then, or is there another place where it opens it up wider than that? In your previous drafts, you had addressed the issue of the quality of care as % f(x) = 0

well.

690 CARLSON: If you look on the bottom of Page 2, starting in Subsection 4-D, it talks about acting in an advisory capacity to the Senior and Disabled Services Division on matters pertaining to quality and reimbursement. I think this Council's scope would be limited to those two particular areas in that section.

819 KENNEMER: How do my -7 Amendments differ from the -1 Amendments, that would exempt the DEQ?

837 LYDIA TAYLOR, DEQ: The difference would be that DEQ is proposing that some DEQ staff be exempted from the Sanitarians Registration Board, but those who do on-site work, which we feel is relevant to Sanitarian work, would be registered. The amendments that you're proposing would be much broader and would exempt people from other state agencies and would also exempt these people.

844 KENNEMER: It would also allow anyone who wanted to, to join up.

854 MCCOY: Would you respond to the -5 Amendments?

858 RON BAKER, Chair, Sanitarians Registration Board: Our amendments would allow us to do away with the Sanitarians trainee exam, which means that if they have the educational background, which probably 99% of them do, they can be registered as trainees immediately, and we'll give them two years to

get the necessary training for the examination.

877 MCCOY: Asks Taylor to respond also.

879 TAYLOR: The Department believes that the Sanitarian Registration Examination is very specific to certain activities which are not done by DEQ: inspections of swimming pools, inspections of restaurants, inspections

of food processing, etc. We don't do that work. Those things that are specific to DEQ, such as on-site septic system inspection, we agree should be registered. But, we don't feel that the test that is offered by the Sanitarians Registration Board relates to what we do, and therefore it does

not add value to protect the public and we had asked the Board to change the exam, but they did not wish to do so.

492 MCCOY: What about the educational background? Is it just about the same for both Sanitarians and DEQ?

493 TAYLOR: I believe Ron Baker could better answer what their expectation is on training. The people who we expect to be registered would have training in soil sciences, in sanitary sewer systems, and that kind of thing. They would not have training in food processing inspection, any radiation kinds of things, or restaurant food handling inspections.

500 BAKER: The exam that's given relates to DEQ probably 75%-80%, more than

any other agency or division. We administer the test, we know what's on it.

We've broken it down. It applies to air quality, water quality, solid wastes, hazardous wastes, as well as food and swimming pools. It applies more directly to the things that are done by DEQ than any other agency in the state of Oregon.

507 MCCOY: What about classification for salaries?

509 TAYLOR: Responds.

518 MCCOY: But you call them Sanitarians.

519 TAYLOR: No, we don't. We call them Environmental Specialists, and only people who work in the on-site system who are registered Sanitarians would be called Sanitarians by DEQ.

522 KENNEMER: Are there problems with your people being incompetent and creating problems by their lack of knowledge? Are their difficulties in managing people who don't behave in competent ways in your department?

526 TAYLOR: We have excellent, highly-qualified staff at DEQ. If we do have problems with employees, we take actions as any state agency should to modify that employee's behavior. We have people who typically have Masters degrees or better in their field of expertise.

532 CHAIR BUNN: We're going to bring this bill back for one more work session. You all need to talk amongst yourselves and see if you can find any basis for compromise, because if there isn't, the committee's going to take it over and you have no idea what you're going to get.

538 DIANA GODWIN, representing Steve Wert & Associates: We don't disagree that people who do on-site, sub-surface sewage work should be brought in under the Sanitarians Registration Board. I believe the DEQ also agrees that its employees that do the on-site, sub-surface sewage disposal work should be brought in under the Board. What my -4 Amendments do, is create what we consider a more rational approach to licensing those people under the Sanitarians Board for doing on-site work. We're going to make them meet

the highest possible education and experience requirements, but what our amendments specify is that people who meet those education and experience requirements for being a registered Sanitarian, do not have to take the general exam that deals with swimming pool inspection and food inspection, etc. because it does not relate to what the work that an on-site Sanitarian

would be doing. Therefore, in our -4 Amendments, we also create a special category of Sanitarian called a Waste-Water Sanitarian. They will be limited to doing only on-site waste work. They will not be doing restaurant

or other inspection work, and therefore the DEQ employees who will be registered if they do on-site work will have two ways to become registered.

Hopefully, that will help out the agency when they have to undertake the cost to bring their on-site people in under the Sanitarians Registration Board. They can either meet the high education and experience requirements and be a Waste-Water Sanitarian, or they can take the general exam and be a

## general registered Sanitarian.

573 MCCOY: All of them ought to be brought up to the highest possible standards, and they all, if they're doing something that's related, especially the on-site people, in case of an emergency, we would need all of these people and we would need them with the full complement of abilities, background and training. So, I think Mr. Wert ought to be a Sanitarian. He ought to take the exam and be ready to go if we needed him in an emergency.

584 GODWIN: My client has no aversion to taking an examination, if the examination related to the work that he's going to be called on to do. I want to make one other point, and that is that the reason we have this is because DEQ wishes to privatize portions of its on-site permitting process,

and I think all of us who are concerned about re-inventing government support that privatization effort, but DEQ can't contract with my client unless he's a registered Sanitarian, so it thwarts one governmental objective of involving the private sector more in the permit process.

603  $\,$  LEONARD: I have some concerns about both sides. It would be a relief to me if the parties involved were able to reach some kind of consensus on

this issue.

605 CHAIR BUNN: I can't stress enough the benefit of all three parties to try and come up with some kind of consensus.
