SORENSON: Does this modify any of the ballot measures? 207 MCDONALD: It would modify ballot measure 11, let me describe how it will do it. 220 SEN. SORENSON: There is concern about modifying ballot measures. What is the rational for this? 235 MCDONALD: This is not a reduction, it is an addition. It deals with a potential issue. 240 SEN. HAMBY: Did we discuss another referral to the people to correct it? 241 MCDONALD: No. There is a time problem to be able to do that. 266 SEN. HAMBY: Is there sympathy to refer? 273 MCDONALD: I have only heard rumors. SEN. HAMBY: We are going to have some kids caught in this bind. 280 284 MCDONALD: We just want to deal with a very specific legal challenge. 299~ In my dash 2 and 3 amendments, I tried to lift the Senate Bill 1 language, section 49. I just saw the final copy of SB 1, there may be some minor changes to how the lesser offenses are handled or the definition. 316 TAYLOR: I would like to confer with Mr. McDonald in the hall about this. 346 SEN. MILLER: We will recess for the discussion. 346  $\,$  SEN. MILLER: At this time I will reconvene the meeting.
