004 BETSY BAILEY: AOI, testifying in support of SB 464 and the -1 amendments.

006 LARRY AMBURGEY: Testifying on SB 464.

032 LARRY AMBURGEY: This is a very delicate bill. Discussing the SB 464-1 amendments.

065 LARRY AMBURGEY: Discussing covered employers in Section 2. The number of employees has changed from 50 to 25.

- 090 CHAIR DERFLER: What do you mean by protected time off?
- 140 LARRY AMBURGEY: Discussing medical verification. Employer may require medical verification in certain situations.
- 185 LARRY AMBURGEY: Discussing the right of the employer to recover costs if the employee does not return to work.
- 212 LARRY AMBURGEY: The right to use sick leave during family leave will be up to the labor contract and employer.
- SEN. LEONARD: Did I understand that the employer has the right to require medical verification if an employee is absent for more than 3 days with a sick child.
- 295 SEN. LEONARD: The major 2 differences of this bill are the medical verification and use of sick leave.
- 325 JACK ROBERTS: BOLI, testifying on SB 464 (EXHIBIT A & B).
- 370 SEN. MCCOY: There have been seminars for employees and employers to help them understand the law.
- 400 JACK ROBERTS: Explaining the chart (EXHIBIT B).
- 430 JACK ROBERTS: Discussing the changes of Oregon Law from the Federal Law.

- 047 LARRY AMBURGEY: You are right, under current law. AOI has no problem clarifying the language of that section.
- 055 SEN. LEONARD: Is the current law that you do not need medical verification for caring for a sick child?
- ${\tt 060}\,{\tt JACK}$ ROBERTS: Explaining the reason for the medical verification section.
- O87 CHAIR DERFLER: If we are going to change the rules from the statute, I think we should change the statute.
- 115 JACK ROBERTS: Explaining the reductions in the bill.
- 118 SEN. KINTIGH: How is the number of 25 employees calculated?
- JACK ROBERTS: The employee has to work at least 25 hours a week and the
- employer must have over 25 employees for more than 20 weeks out of the year.
- 150 SEN. LEONARD: Would job-share employees be eligible?
- 200 LARRY AMBURGEY: This has no impact on job share at all.
- 250 CHAIR DERFLER: How did you pick the 25 hour figure?
- 270 CHAIR DERFLER: We have to be sensitive to both sides.

- SEN. BRYANT: I draft employee policies for clients and I always tell them just to follow state guidelines. I appreciate the effort to make the law clear.
- 315 SEN. BRYANT: In your review, is this a substantial financial impact on employers?
- 340 LARRY AMBURGEY: Explaining the financial impact.
- 370 JACK ROBERTS: In balancing equities, we are taking out sick leave so we

have asked the employer to continue paying for insurance coverage at the same percentage as if the employee was still working.

- 400 SEN. BRYANT: Discussing the problem with the employer trying to collect from the employee if the employee does not return to work.
- JACK ROBERTS: In our original bill, we wanted to make it the same if you are caring for a sick child as if you are sick yourself.

- JACK ROBERTS: We want to balance the equities between those who have good benefits with those who work for smaller employers.
- O50 SEN. LEONARD: The reality is you are going to force people to be dishonest. Employees will be forced to say they are sick in order to get sick leave for caring for a sick child.
- 1068 LARRY AMBURGEY: You can't say that pregnancy will be treated differently than any other type of sickness under the law.
- O80 SEN. BRYANT: It is important to remember that many small employers do not allow for any sick leave or vacation.
- 105 SEN. BRYANT: I appreciate the thoughtful consideration you have given this bill.
- 115 VICKIE TOTTEN: Oregon School Boards Association, testifying on SB 464 (EXHIBIT C).
- 153 CHAIR DERFLER: How would you prevent that?
- 157 SEN. LEONARD: So you are testifying in favor of the employer continuing insurance coverage?
- 180 VICKIE TOTTEN: There are very few school employees who are not represented.
- 212 LAURIE WIMMER: Testifying on SB 464 (EXHIBIT D).
- 255 LAURIE WIMMER: Discussing page 4, sub 4.
- 300 LAURIE WIMMER: Discussing problem with -1 amendment where employer could require a second opinion.

- 325 CHAIR DERFLER: Do health care providers recognize Naturopaths?
- 350 LAURIE WIMMER: We would like the hours worked dropped back to at least 20 hours, if not eliminated entirely.
- 400 LAURIE WIMMER: We believe the job protection amendment cuts back on the deal we made.
- 440 LAURIE WIMMER: We want a clarification on the available job section.

- 030 LAURIE WIMMER: We feel we are better suited to present the workers of Oregon. Leave rights would be out of reach of the working poor.
- 060 LAURIE WIMMER: We would like to have a retaliation clause added to protect the employees from discrimination by employers.
- 100 SEN. LEONARD: Can you live with the -1 amendment if the -2 and conceptual amendments are also passed?
- 105 AMY KLARE: AFL-CIO, testifying on SB 464 (EXHIBIT E).
- 140 AMY KLARE: Encourages committee to pass -2 amendments.
- MARIANNE GEST: OPEU, testifying on SB 464. We oppose the -1 amendments and support the -2 amendments.
- 170 SEN. LEONARD: Are you saying there was an agreement to leave in sick leave use?
- 182 LAURIE WIMMER: We could not agree on 2 issues.
- 202 MARY BOTKINS: AFSCME, testifying on SB 464. Discussing how sick leave will be handled.
- 216 FRANK BRAWNER: Oregon Bankers Association, testifying in support of SB $464~\mathrm{with}~-1~\mathrm{amendments}$.
- 260 FRANK BRAWNER: Discussing the 20 mile limit for job replacement for returning worker.
- SEN. LEONARD: Did I understand you to say that employees were allowed to use sick leave for family leave in the banking industry back in the 60's?
- 300 FRANK BRAWNER: Our sick leave policies have diminished because of current law.
- 301 SEN. MCCOY: Do you like the -1 amendments?
- 310 BOB HALL: PGE, testifying on SB 464 use of paid sick leave.
- 350 SEN. LEONARD: What is your current policy on use of sick leave?
- 390 BOB HALL: PGE has a very liberal policy.

- 415 SEN. LEONARD: If PGE pays unused sick leave at retirement, I have a hard time grasping why they would not allow employees to use that same sick
- leave for care of newborns.
- 467 BOB HALL: Explaining the 3 different leave plans being combined into one.

- 200 SEN. KINTIGH: Many employees do not have any wage replacement for time off work.
- 212 SEN. LEONARD: Could you live with the hour requirement of 25 hours of work per week?
- 225 SEN. MCCOY: Would you have a preference on the 180 days or 90 days?
- 240 CHAIR DERFLER: Closing PUBLIC HEARING on SB 464.
