001 SEALOCK: Indicates that the county clerks strongly support the measure.

023 SEN. ADAMS: Asks for clarification as to the liability: would it lie with the committee director or the treasurer?

030 SEALOCK: Answers that there is joint liability.

040 SEN. ADAMS: Asks why there is additional liability to the committee director, if there is an acting treasurer.

055 SEALOCK: Responds that the intention behind joint liability is to provide a double check to contributions and expenditures. Calls for the need to statutorily require a second person check the records.

071 CHAIR MILLER: Asks for examples wherein problems occur.

076 TAMMY DUTWEILER, Secretary of State's Off~ce: Answers that, often, committee directors will send a letter of resignation to the Secretary of State's office. Explains that these situations are problematic.

084 MARGE BECKERIDGE, Executive Director, Oregon Republican Party: Notes that she has requested changes to the measure.

092 BECKERIDGE: Indicates that political party committees need to be referred -to separately. Would like to allow for the designation of an assistant treasurer. Indicates that federal law allows for such a position.

127 SEN. ADAMS: Refers to -1 amendments (EXHIBIT D). Asks if it is Beckeridge's desire is to change line 5 "political committee" to "political party committee?"

voter's pamphlet statements.

380 -Explains that the impact of contribution ceilings are relevant to local political action committees,

but not to statewide PAC's such as Oregon Taxpayer's United. Indicates that no matter what is

spent, and no matter what locality it is spent, contribution and expenditure reports are required.

011 SIZEMORE: Explains that it isn't desirable for the committee to establish a separate PAC for each local campaign. Concerned with the subjecting of the organization to high fines.

024 SEALOCK: Notes that testimony from the Secretary of State's office is based on collections from state organizations. Notes that smaller contributions make a much greater impact in local elections.

 $040\ \text{SEN.}$  PHILLIPS: Asks for the standard charges posed for pages in the voter's pamphlet.

045 SEALOCK: Answers that when a statewide agency files a local report or a local statement in the voter's pamphlet, there are questions. Explains that there are many offices to file. Explains the way they would resolve concerns.

082 CHAIR MILLER: Discusses the granting of discretion by the Secretary of State's office. Discusses the need for protection from citizens who come forth with flaws in the filing documents from fines.

103 SEALOCK: Says that there is a need to avoid the position of determining integrity in claims.
