TAPE A 003 CHAIR MILLER calls the meeting to order at 9:40 a.m. Opens Public Hearing on Munn reappointment

015 RICHARD MUNN: Testifies that he has been in the position with the Department of Revenue for over thirty years and served under seven Governors.

CHAIR: Is any legislation pending which changes or improves the Department?

MUNN: Refers to a measure which changes the appeals process.

CHAIR: Are there any measures dealing with the collections process?

MUNN: The budget had a bill to add additional auditors and collectors to generate approximately \$21 more in revenue. It passed out of Ways and Means and has already been through the legislative process.

Opens Public Hearing on Rankins reappointment

CHAIR: Notes that Mr. Rankins has been appointed Chairman of the Association of Racing Commissioners International

048 GEORGE RANKINS: Talks about the international association.

SEN. SPRINGER: Are two terms the an unofficial limit on Boards and Commissions?

070 KATY COBA, Governor's Assistant for Executive Appointments: The Governor has adopted the policy of two four-year terms or eight years of service on various boards and commissions. There is flexibility for special situations and exceptions. Mr. Rankins situation warrants an exception to that policy.

> Don't think Mr. Rankins is interested in serving another complete four-year term on the Racing Commission.

Opens Public Hearing on Walters reappointment

WALTERS: The position being assumed by Commissioner Rankins is a prominent

one in racing in the U.S. It is a great honor for Oregon to have one of it's commissioners assume this position.

102 CHAIR: Are you compensated for your work?

WALTERS: Receives \$30.00 for each day spent on Racing Commission business.

Paperwork to get the compensation is more trouble than it is worth. Commission meets once a month and there are various committee meetings.

CHAIR: What sort of business is typically conducted by the Commission at it's meetings?

WALTERS: Commission meetings are in two parts - quasi-judicial capacity in

the morning and discuss a wide range of issues in the afternoon. Explains how he became involved with the Commission.

SEN. SPRINGER: What about the future of paramutual betting and racing in Oregon?

WALTERS: Paramutual wagering is subject to very intense pressures. Ability to simulcast races from other states has saved horse racing in Oregon. Race tracks need to have other revenue options in order to survive

such as video poker machines. Racing is an agricultural industry.

191 SEN. SPRINGER: How have off-track betting opportunities benefited racing?

WALTERS: It has expanded opportunities for people outside the metropolitan

area to participate in racing. It has increased the amount of money bet. Looking at ways to stabilize the simulcasting network. > Talks about Bend Best Bet located in Bend, Oregon.
