Does not believe that citizens wouldn't also seek care from a dentist, even though they had seen a hygenist. 199 responds that citizens would not seek additional care. 260 CHAIR: asks about amendments presented by the American Dental Association. 270 answers that the original amendment offered by the Association was accepted, but that the Association did not support the inclusion of nursing homes. 360 REPRESENTATIVE JANE ROSS, testifies in favor of HB 2089. --Was supported by nursing home directors from her district --Measure gives the Board to establish requirements for dental hygenist/dentist cooperative services Tape 92, B 002 REP. ROSS: testifies that many citizens in nursing homes have no dental

care.
