414 CAM GILMOUR, PROGRAM MANAGER, ODOT: Addresses 400 million dollar shortfall. 427 -Federal revenue assumptions were overly optimistic

483 GILMOUR: We always balanced the books in the budget, but the six-year program in the past had been larger than the budget would actually support.

047 GILMOUR: The current program covers a four-year period and establishes transportation project priorities; the department is trying to match those

project priorities to the available revenue.

140 REP. HAYDEN: What about new projects such as putting a bridge across the Columbia for the light rail?

142 GILMOUR: Don't have too many of those projects in the next two- or four-year periods ready to go.

145 REP. HAYDEN: Will we now be getting four-year booklets as opposed to six-year booklets, and when are those available?

148 GILMOUR: We can obtain those at your request.

150 CHAIR BAKER: Requests four-year booklets for members of both committees.

152 CHAIR BAKER: Is there a particular reason there are no new construction

projects ready to go at this time?

154 GILMOUR: The four-year program identifies projects we can bring to contract within that four-year period; many new construction projects take longer than that to develop.
