TAPE , SIDE A CHAIR BAKER: Calls the meeting to order (1:30PM) and opens as a 003 subcommittee. PUBLIC HEARING ON SB 881, SB 882, SB 1107 Henry Kane, Beaverton, Oregon Witnesses: Chuck Smith, Debt Management Division, Oregon State Treasury Bill Nessly, Assistant Attorney General, Oregon Department of Justice Denise McPhail, Portland General Electric Dick Feeney, Tri-Met Bob Stacey, Esq., Ball, Janik and Novack Jim Sitzman, Oregon Department of Land Conservation and Development 005 ADMINISTRATOR ADKINS: Enters into the record 23 letters supporting [EXHIBITS A through W] and one letter opposing SB 881 [EXHIBIT X]. CHAIR BAKER: Enters into the record letter from Michael Holstun, Oregon Land Use Board of Appeals, stating no concerns regarding SB 882 [EXHIBIT

Y].

Committee begins operating as a full committee.

020 HENRY KANE, BEAVERTON, OREGON: Opposes SB 881. Submits and summarizes testimony and informational material [EXHIBIT Z].

040 -Major financial concerns 125 -Ridership/population issue

200 CHUCK SMITH, DEBT MANAGEMENT DIVISION, OREGON STATE TREASURY: Submits and reads testimony regarding overall debt management for the State of Oregon and how a financing program for light rail may fit within that total

context [EXHIBIT AA].

CHAIR BAKER: You're saying that the use of revenue bonds in this method would not injure the state and would be looked at most likely favorably by bond lenders?

SMITH: Yes.

280 SEN. YIH: Why are you recommending certificates of participation (COP's) for prison construction, while recommending revenue bonds backed by lottery for light rail?

SMITH: Explains why prisons are an ideal project for COP financing. The Treasury's goal was to try to spread financing to other sources of revenue other than the general fund, therefore our recommendation of lottery bonds backed by lottery revenues.

310 SEN. YIH: I want to know whether it's better to use general fund obligation bonds for prisons rather than use COP bonds for prisons.

SMITH: The state currently has no constitutional authority to sell general

obligation bonds to be used for prison construction.

SEN. SHANNON: Has anyone tested certificates of participation in the Supreme Court to see if they are legal?

 $\ensuremath{\mathsf{SMITH}}$: Yes, Mr. Henry Kane tested those in the Oregon Supreme Court, and lost.

340 CHAIR BAKER: Confirms with Mr. Smith and Mr. Nessly that both the Treasury and the Department of Justice have looked at SB 881 and don't find

any obvious deficiencies.

350 SEN. LIM: Concerned we make sure that the South/North Light Rail Project is considered part of economic development, and that there be no lawsuit later on in this matter.

BILL NESSLY, ASSISTANT ATTORNEY GENERAL, OREGON DEPARTMENT OF JUSTICE: Section 2 of the proposed bill contains legislative findings that the use of the lottery monies for this project will promote economic development.

390 DENISE MCPHAIL, PORTLAND GENERAL ELECTRIC: Also advocating on behalf of

U.S. West and Northwest Natural Gas; strike Pacific Power and Light from written testimony. Submits and reads testimony, which includes proposed amendment attachment [EXHIBIT BB].

-Walks through SB 881-1 amendments [EXHIBIT CC]; emergency clause can be removed

-Confirms the proposed amendment is specific to SB 881 only

CHAIR BAKER: Staff will provide you with the Activity/Timeline chart. -Will go into a work session today for amendments; will address the bills again next week

SEN. SHANNON: Have you submitted any verbiage that would make it easier to

appeal?

KANE: No, but I urge the bill be amended so that citizens be allowed to cross-examine Tri-Met witnesses.

SEN. SHANNON: It has to be in the bill or that won't happen?

KANE: That's correct.

180 DICK FEENEY, TRI-MET: Submits and summarizes testimony on proposed amendments to SB 882 [EXHIBIT DD], which are included in SB 882-1 [EXHIBIT EE].

295 CHAIR BAKER: Please comment on the timing of SB 1107.

FEENEY: We are still trying to have C-Tran involved. We decided to go ahead with this legislation at this time because with the attention of this

session of the legislature, we would be ready for a subsequent session of the Washington State legislature; if they have questions or changes they want to make, then we'd have ample time to deal with it. However, we cannot assert that C-Tran is still a part of this project.

ADMINISTRATOR ADKINS: The bi-state Authority isn't referred to in SB 881 or SB 882. How do they work together if the bills just say Tri-Met or ODOT?

BOB STACEY, ESQ., BALL, JANIK AND NOVACK: The objective of the compact legislation is to assure efficient construction and operation of the South/North line. The land use legislation is intended to govern review of

the decision on alignment and routing of the facility, which will be made by the two transit agencies. The Authority takes over at the point the decision is made on the alignment.

ADMINISTRATOR ADKINS: Question regarding Article 10 of the original bill regarding a quorum and a majority vote.

STACEY: It would be wise for the membership of both organizations to have an active role in the governance of the board.

400 CHAIR BAKER: Mr. Feeney, did you see the SB 881-1 amendments proposed by PGE?

FEENEY: Yes, but we're are not prepared to accept them at this time. We have some concerns, and would like to discuss the amendments further with

PGE.

TAPE 43, SIDE B

O20 SEN. YIH: Does this means that Washington State has to pass a similar compact by their legislature in order for this to work?

FEENEY: On SB 1107, they'd have to pass basically the same legislation. SEN. YIH: What's the deadline for passage of the compact by both states? FEENEY: Probably by the end of 1997.

SEN. YIH: You don't have to have the compact before you go to Congress?

FEENEY: That's correct; we need the compact in order to govern construction of the project.

CHAIR BAKER: Intent to move forward on amendments to SB 881, SB 882, and SB 1107; have staff hand-engross, and then look at the bills again next week.

245 JIM SITZMAN, OREGON DEPARTMENT OF LAND CONSERVATION AND DEVELOPMENT: In

a case of this magnitude with the multiple jurisdicitons involved, and the many land use decisions that need to be made, and the critical nature of the timing in order to obtain federal support, it is prudent to have legislation of this kind in place.

SEN. YIH: Is this legislation similar to the siting for the super collider?

SITZMAN: This legislation is more of a modification of the existing system

as opposed to an alternative to the existing system, as was the super collider.

SEN. YIH: Is this similar to the process that was designed for prison siting?

SITZMAN: It's most similar to what was done in 1991 for the Westside Light

Rail.

300 ADMINISTRATOR ADKINS: What's the difference between a limited and a non-limited land use decision?

SITZMAN: Technically, this doesn't fall under the definition of a limited land use decision; briefly defines a limited land use decision.
