TAPE , SIDE A 003 CHAIR BAKER: Calls the meeting to order (1:24PM). WORK SESSION ON SB 626 010 ADMINISTRATOR ADKINS: Reviews SB 626 proposed hand-engrossed version [EXHIBIT A]. 070 SEN. LIM: Since this is a private project, why should the prevailing wage law apply? CHAIR BAKER: The concern is that this is a public and private mix of funds. SEN. SPRINGER: Explains why he raised the question of prevailing wage. SEN. SHANNON: How much of the public money is going to be repaid? CHAIR BAKER: The private money will be repaid. The project will revert to the State of Oregon at a certain point in time. Taxpayers get their money back ultimately.

100 SEN. LIM: Concern that mandating prevailing wage could be a detriment to the project.

CHAIR BAKER: The project is probably subject to prevailing wage law as it is now, but including it in the bill would make it more clear.

130 SEN. LIM: Wants the language to be clear, but allow enough room for either to apply.

SEN. SPRINGER: Concern for being sued, and assumption that some public dollars is going to be expended on this project. Philosophically, if it's going to be substituted for what would be a public project, it ought to be subject to prevailing wage.

CHAIR BAKER: There's nothing preventing another project. Expands upon why he opposes Sen. Yih's motion.

PUBLIC HEARING ON SB 442

Witnesses: Bill Johnson, Lieutenant, Oregon State Police Jerry Cooper, Governor's Advisory Committee on DUII Kelly Taylor, Manager, Driver and Motor Vehicle Services (DMV) 285 ADMINISTRATOR ADKINS: Explanation of SB 442-2 amendments [EXHIBIT I], which replace the bill.

310 BILL JOHNSON, LIEUTENANT, OREGON STATE POLICE: Requests the word "motor"

be removed from the SB 442-2 amendments, line 6.

JERRY COOPER, GOVERNOR'S ADVISORY COMMITTEE ON DUII: Recommends the process by which DMV makes record entries be changed, not the elements of DUII. Does not want the word "motor" included as in the SB 442-2 amendments, line 6.

380 KELLY TAYLOR, MANAGER, DMV: Explains "quandary" regarding the statutes and DMV processing of DUII citations as specifically related to non motor vehicles. Requests conceptual amendment that says non motor vehicle related convictions, if found outside of Chapter 814, are not sent to DMV and not posted.

440 ADMINISTRATOR ADKINS: Doesn't something happen to a minor's driving record for alcohol-related offenses?

COOPER: Correct, any alcohol or control substance related offense affects 13 to 17 year olds driver license or right to apply.

TAYLOR: States DMV wants language to specify that a conviction under ORS 813.010 is only posted to a driving record if it was motor vehicle related.

475 CHAIR BAKER: Legislative Counsel will draft something and we'll hear the bill again.
