TAPE 61 SIDE B 001 BURGESS: Concludes her testimony and discusses briefly the land use rights of an individual owner with Chair Johnson. 018 BURGESS: In response to Chair Johnson, Ms Burgess states that the regulation is done for a reason and it may increase the value of life and the value of the property , and because of this it needs to be factored in. 025 CHAIR JOHNSON: Neither SB 600 or SB 531 apply to land use regulations. 050 BURGESS: In response to Sen. Bryant Ms Burgess explains her directives on tax incentives and other goals to compensate people for land taking's. 084 Questions the net effect on the general fund, whether SEN. KINTIGH: a payment or an incentive have the same effect. 086 BURGESS: That is correct.

087 SEN. DWYER: Why do we have these policies?

090 BURGESS: It is an incentive to get land owners to be good stewards.

094 CHAIR JOHNSON: Questions the level of contribution in compliance to compensation.

096 BURGESS: A basic standard needs to be met, not by a percentage.

106 CHAIR JOHNSON: Gives an example relating to a specific individual who is asked to give up a measurable size of land and questions Ms Burgesses on whether they (the individuals) would be entitled to compensation and who benefits from the taking.

120 BURGESS: Responds by clarifying that the individuals in Chair Johnson's scenario would not be entitled to any compensation in her opinion and it is

the public that would benefit from the taking.

140 CHAIR JOHNSON: Suggests another hypothetical situation that could arise that would present a need for compensation.

149 BURGESS: We should use some sort of voluntary means to reach compensation to get to the standards that we are looking for.

153 CHAIR JOHNSON: Questions if the individual in his hypothetical situation was a retired individual with no income that would be devastated financially by being asked to voluntarily give up his land, because tax incentives and so forth would have no bearing on his financial situations.

161 BURGESS: There are incentives being working on that could be available to

use, but I don't have any at this time.

181 SEN. DWYER: Is the current system broken?

183 BURGESS: No.

186 SEN. DWYER: Questions the tax benefits.

189 CHAIR JOHNSON: Explains the loss of tax benefits.

201 SEN. DWYER: Isn't that a benefit that the entire community gives to that individual for contributing to the whole of society?

204 CHAIR JOHNSON: However those are irrelevant here, these bills address

when the government comes along and takes the land owners ability to make a

living off of their own property; it is essential that there is some form of compensation for these individuals so that they can maintain.

208 SEN. DWYER: Explains his views on the 10% issues.

210 CHAIR JOHNSON: That is correct, but the Governors office doesn't agree that even above 10% their should be compensation.

214 JIM BROWN, STATE FORESTER: Testifies in opposition to SB 600. Addresses the nature of SB 600 and SB 531. --Agrees with Ms Burgess' conclusion of the responsibility of the property owner to uphold the standards of the society with little compensation.

291 CHAIR JOHNSON: Asks for clarifications.

293 BROWN: Explains the different approaches using SB 531 as an example.

018 CHAIR JOHNSON: Asks for advice on language that could upgrade the clarification of SB 600.

020 BROWN: Expresses his opinions. --Explains the level that should be addressed as a thresh hold of taking's.

034 CHAIR JOHNSON: Questions about cruising and developing a standard of recognizing the value with out the restrictions.

046 BROWN: That can be done. --Responds to Sen. Bryant about a green IRA. --Explains the tax incentive process --Responds to Sen. Johnson on the Timber Industry in Oregon and how it relates to individuals not being compensated because they have no protection provided by SB 600, and the effect that it has on the state

of Oregon's economy.

097 CHAIR JOHNSON: Do you agree that the "eco takes" have an economic impact on not only the individual, but the states economy as well?

102 BROWN: Yes, but a balance needs to be met to up hold the standards of

land and its environment.

103 SEN. DWYER: How is the process working now? Is it currently "broken?"

105 BROWN: It's working exceedingly well. In terms of how many times the

board has been asked for compensation. We have had a lot of concern from individuals, but on whole the communities have ultimately felt that the board has done a good job of maintaining.

122 SEN. DWYER: Shouldn't there be some method to regulate the taking's?

A small taking could be very devastating to a land owner who only owns a small parcel of property.

126 BROWN: I agree.

130 BRUCE ANDREWS, DIRECTOR OF THE OREGON DEPARTMENT OF AGRICULTURE: Testifies in opposition to the present form of SB 600 and encourages voluntary approach.

--Explains the responsibility of the land owners.

--Concludes his testimony by suggesting the opportunity for change and cooperation needs to be addressed.

190 LOUIS PITT, WARM SPRING CONFEDERATED TRIBES OF OREGON: Testifies in Opposition to SB 600. (See Exhibit C)

274 JAY MINTHORN, CONFEDERATE TRIBES OF THE UMATILLA INDIAN RESERVATION: Testifies in opposition to SB 600. (See Exhibit D)

003 MINTHORN: Continues his testimony in Opposition to SB 600, reading his testimony provided in Exhibit D.

056 CHAIR JOHNSON: Questions the bills impact on the tribes rights to harvest resources from private lands.

069 JEFF VAN PELT, CONFEDERATE TRIBES OF THE UMATILLA INDIAN RESERVATION:

--The treaty provides the tribes the ability to cross lands to harvest fish

and any restrictions placed on the lands to inhibit the tribes from harvesting the fish is in direct violation to the rights specified in the treaty.

077 CHAIR JOHNSON: Explains that the rights granted under the treaty is a

federal law which takes precedence over any state law. SB 600 would not effect the rights provided to the tribes by their treaty.

088 Explains how the tribes should be sensitive to those whom SB 600 would be protecting from the taking with out compensation of private lands, by the government.

097 VAN PELT: Expresses his concerns about the cost that will occur by managing SB 600.

100 CHAIR JOHNSON: Questions about the Winans Case and the rights of the tribes.

119 VAN PELT: Explains

--Responds to the questions of how the lands are managed. Directing the responsibility of the individuals for maintaining the standard of the lands.

136 CHAIR JOHNSON: Discusses with Van Pelt the status of the current land and the authority that the tribes have over private lands.

148 KATHYRN HARRISON, VICE CHAIR OF THE CONFEDERATE TRIBES OF GRANDE RONDE:

ED LARSON, ED PEIRCSOL, BOB HALLOR, MIKE MEASON: COUNSEL FOR THE CONFEDERATE TRIBE: Testifies in opposition to SB 600.

--The Confederate tribes of Grande Ronde can not support SB 600 unless the archeological aspects of their ancestries are protected.

196 CHAIR JOHNSON: Ask if the other tribes would be able to support SB 600 if a protection was granted to their ancestral remains.

198 VAN PELT: Not Umatilla.

199 PITT: Not Warm Springs.

201 VAN PELT: Our position is to protect the natural resources granted to

us by our treaty rights. We do agree that the Ancestral remains do need to be protected.

206 CHAIR JOHNSON: Asks if the tribes counsel could send him a letter further explaining the treaty rights and how they are attacked by SB 600. --Also ask for a statement that helps him understand the current laws of the tribes and their control of lands off of the reservation.

224 SEN. CEASE: If the State tries to take property that is off of the reservation that is protected under the treaty rights, is it my understanding that no one is entitled to compensation?

232 VAN PELT: The treaty rights are protected under Federal laws. If land practices are not managed to keep the wild life up to the standard, then you are jeopardizing our treaty rights.

254 MINTHRON: We look towards coopertive management to work together. Most issues can be worked out cooperatively.

268 CHAIR JOHNSON: Recesses the Public Hearing for five minutes.

279 JUDY GERRARD, CITIZEN: Testifies in opposition to SB 600.

TAPE 64 SIDE A

010 Continues testimony. (See Exhibit F)

040 HOWARD PAINE: Testifies in opposition to SB 600. (See Exhibit G.)

--You testified that the courts already protect individuals for the "evil that we are trying to kill here." So if people are not protected, do you think this bill would be necessary?

254 BRODIE: Not necessarily through state legislation.

255 LESLIE MILLER: Testifies in opposition to SB 600.
