CONFERENCE COMMITTEE ON SB 1033

Witnesses: Martha Pagel, Director, Oregon Water Resources Department

005 CHAIR BRYANT: Calls the meeting to order (2:06PM).

-Lists the participants who have reached an agreement

-The last meeting concluded with the -11 amendments with one correction.

MARTHA PAGEL, Director, Oregon Water Resources Department : Presents 020 additional language required on Page 2, line 20, of -11 amendments; up to but not exceeding the amounts.

CHAIR BRYANT: Presents overview of bill and amendment. 040

REP. JOSI: Wants further clarification on the word "field". 055

CHAIR BRYANT: Clarifies "relevant field" information.

102 PAGEL: Responds to SEN. DWYER's concern regarding subsection A. -Discusses the interpretive language that she has some concerns regarding lines 8 and 9

-Continues discussing "relevant field data' and the granting of water rights with SEN. DWYER.

SEN. DWYER: Expresses concerns regarding diminishing water and scenic 140 waterways.

CHAIR BRYANT: Discusses hydraulic connection presumption and the definition of "interference",

180 SEN. DWYER: Expresses concern as to who is being cut off 10 years later, when 5,000 new houses are established and it is discovered there's a connection and the river is being measurably affected.

CHAIR BRYANT: Discusses managing aquifers.

PAGEL: The permitting requirements do not apply to exempt domestic wells. Secondly, if area where experiencing collective kinds of interference, those are the kinds of areas where we can move forward with declaring a critical ground water area and make necessary adjustments.

210 SEN. DWYER: Asks for clarification on the interaction of aquifers.

PAGEL: For each groundwater use, by using certain kinds of mathematics models that have been developed, a geologist can calculate at what point there can be a discharge or lack of discharge or interference with the surface water. Most likely that would be downstream.

252 Continues to explain the effects of the proposed new statute.

257 SEN. DWYER: Asks for clarification regarding agreed water rights.

260 REP. NORRIS: States the committee should get the hydrology issue out to

work on and it can later be amended.

CHAIR BRYANT: Assures that the procedures are based on science and water law, and the experience of the Water Resources Department.

319 MOTION: REP. JOSI: Moves SB 1033 -B11 amendments dated 6/3/95 BE ADOPTED and that the bill be further amended and REPASS the bill.

VOTE: Hearing no objection the motion CARRIES.

MOTION: REP. JOSI: Moves the Senate CONCUR in House amendments dated 05/17/95 and that SB 1033B be further AMENDED and REPASSED.

VOTE: 5-0

AYE: In a roll call vote, all members present vote Aye.

CHAIR: The motion CARRIES.
